

In the Name of God amen.

I Solomon Whitson of the County of Union, & State of Sc. Caroline. (Shoemaker being indigested in Body, but of Sound mind and Memory) do make & publish this my last Will & Testament, in manner following (Viz.) I command & bequeath my soul to God, & my Body I commit to be decently Buried, at the Discretion of my Executors. ---
And as to my worldly Estate, I dispose of as followeth, (that is to day) First, I will & Appoint that all my just Debts & Funeral expences be paid out of my Real & Personal Estate, by my Executors, hereafter Named & Appointed. ---

1st As my Estate in Lands, I leave unto my Sons (David and Willis) a Tract containing Two hundred & fifty Acres (More or Less) as the Deeds expresses, Adjoining to Wm. Wood's Land, to be equally Divided in quantity & quality - - - - -
2nd I leave unto my Sons (Jordan & Samuel,) a Plantation of Two hundred Acres, (Situate between the above Tract & the one hereafter mentioned) to be Divided in quantity & quality) between them.

3rd I also leave a Plantation of Three hundred and Eleven Acres Adjoining Wm. Gist's Plantation; in the County aforesaid unto my other two Sons Solomon & John; & I will, that ^{sd} Solomon & John do as Convenience & ability permits, pay unto Jordan & Samuel Fifteen Pounds in Horse or any Good Trade - - - - -
And as to the rest of my Property both Personal & Real I give to my well-beloved wife Phebe, to be at her disposal & Command whilst she liveth; and at the time of Maturity or full Age of my Sons, she give a part of the Horses, Cows, Hogs & Sheep, as she shall see meet to dispose of the same, equally amongst my Sons, still Retaining to herself of Choice One Horse creature, & one Cow for her support. - Also all the Household Furniture of what kind soever, to her only use and Disposal. - Also I ordain that she shall have on the above Plantation of Solomon and John, as

long as she remains a widow,

And

And if she Marry again, she shall have at her Disposal one good Bed with the Furniture thereof; and all her Pewter now in her Possession, and all her such like Necessaries. - - - -

And concerning an hundred Pounds Pennsylvania Currenny (which was left by my Father, to the support of my Sister Clement, whilst she liveth and then to be conuerted to me) When recoverd I will that to be equally Divided between my Children, Sons & Daughters, Viz. 1st Ann, 2nd David 3rd Mary, 4th Willis,

5th Jordan, 6th Samuel, 7th Solomon, 8th John, - I do Also Nominate & Appoint my dearly beloved wife, Phoebe Executrix; and my Sons David & Willis & SoninLaw Thos Robards Executors together with my wife of this my last Will and Testament; to put in execution this my s^d Will agreeable to the Tenor thereof. And further, I do renounce all other Wills heretofore made by me, & acknowledge this to be my only and alone last Will and Testamant. In Witness whereof I have set my hand and Seal this Twentyninth day of the Fifth Month on May, in the Year of our Lord one thousand seven hundred & ninetyeight. - - - - -
