hood I also Lend to my wife one mare by the name of bay peggy
dursing her widowhood and if She Should marry or die before
her Children is Raised I Direet my Exer^s to take the above
mentioned negroes and beaft (to wit) Jenkins diner and bay
peggy and put them to the best use that they Shall think
proper to the maintaining of her Children and after her young-
est Child Jincy Comes of age or marrys then the above named
negroes and beaft are to be sold for Cash and the money to
be Equally divided between my Children (to wit) Elizabeth,
polley, Fanny word. Cisley & Nancy, Henderson - - - - -
Likewise I Give and bequeathe to my Daughter polley Hender one
negro woman named dife with her futer increafe Likewise one
feather bed and furniture and one Cow and Calf I also Give
to my five youngest Children one Shilling Sterling Each to
them and theirs forever
Likewise I Give and bequeeth to my Daughter Elizabeth Henderson
one negro woman named Agg With her futer increase and one
mare by the name of black peggy and Colt Likewise one feath-
er bed and furniture and one Cow and Calf - - - - -
Likewise I give and bequeath to my Deaughter Cisley Henderson
one negro Girl named betty with her futer increase Likewise
one White Horse and one Cow and Calf and heifer - - - - -
Likewise I Give and bequeath to my daughter Nancy Hender one
negro girl named dol with her futer increase; and heifer - -

Likewise I Give And bequeath one negro girl named milley to three of my Grand Daughters (to wit) nancy, jincy and peggy word; with her futer increase to them and theirs for ever notwithstanding the sd negro girl milley with her futer increase I Lend to my Daughter Fanny word during her Life and then to be Equally divided between the above mentioned grand Children

Likewise I Lend to my wife two Cows and Calves for her and her Childrens use and to be dealt with as above I have already given what I intended to my two Sons (to wit) Nathl & W^m Henderson

Likewise I give and bequeath to my Daughter Judy hall the ballence of her granfather durvins Estate to her and her heirs for ever - if either of my Daughters should die without marrying (to wit) Elie - polley - Cissy and Nancy henderson then what I have given them shall be Equal divided between the other three I direct and appoint my Son Nathl henderson and John henderson son of David henderson to be my Executors; witness my hand and Seal this twenti Sixth day of May one thousand Seven hundred and ninety four - - - - -
