and Declared Either By word or Writeing and this to Be my Left  
Will and no other and firft Being ponnitent & Sorey from the  
Bottom of My Hart for My Sins paft moft Humbly Defireing for-  
givenefs for the Same I Give and Committ My Soul to Almighty  
god My Savour and Redemer In home and By home throw the Merites  
of Jefus Chrift I trust and do Delive afuredly to Be Saved and  
to have a full Remifsion and forgivenefs of all my Sins and  
that My Soul With my Body at the genneral Day of the Resurec-  
tion Shall Rife again and with Joy throw the merrites of Jefus  
Chrift Death end poſſion poſſefs and Inherit the kingdom of  
heavn prepared for his Elect and Chosen and my Body to Be Burred  
in Fuch a place where it Shall pleafe My Executors hereafter  
Mentioned to Apoint and for The Seteling of my temporal Eftate  
of Such Goods & Chattels and Lands and Debtes as it heath  
pleased God to Beftow to me & firft I do Give and Difpoſe the  
Same in the meanar and form following & that ifto Say firſt all  
Debts dues and Lawfull Demand that I owe to aney person or per-  
sons whatſoever Shall Be Compelyed with and paid or ordered to  
Be paid within Convenient time after my Deceas By my Executors  
hereafter named Atom I Give and Bequeth one Shilling Sterling to  
my Son williem young Likewise I Give and Bequeth to my Son  
George Young one Shilling Starling Laftly I do Give and  
Bequith to my Well Beloved wife Catterin young the hole of all  
my Goods and Chattels and houſehold furneture Debts dues and

demand whatsoever and Likewife my Land hir Lifetime which Land  
I after hir Deceas I order to Be given to my youngest Son Chrif-  
tephor young my hole and Seal Executor in testemoney whereof I  
have hereunto Set my hand and Seal the day and Dede above writ-  
ten
