

In The Name of God am I turner Rountree of the state of South Carolina Union County Now of a sound and Perfect mind and memory Do Costitute and ordain this to be my Last Will and testament revoking all other Wills heretofore made First it is my desier that all my Lawfull Debts be Paid Item I give to my Son Woodson Rountree Two Negroes viz David and Gabriel Two Cows and one Set of Wagon Wheels-----

Item I give to my William Rountree Eight Negroes viz Lucy----- Lewis Sam Jonas Jane Sarah Isack and Chaney also all my Lands Lying on both sides of Fairforist Creek with my housis and all my household Furniture thereon belonging Also the hole Stock of horses Cattle hogs and Sheep but I Lend to my wife all that I have willid to my Son William as Long she Lives and after hir death then my Son William is to Receive it in----- his Posession and Not before Item I Lend to my Daughter Molley Blasingame Four Negroes viz Phillis Cook Prince and Lucy as Long as She Lives and after hir death For the said Negroes to be divided Equally between hir Children Item I give to my Daughter Molley and hir husband Thomas Blasingame one Shilling Each Which is all that I do Alet for them--Item I lend to My daughter Salley Birdsong one Negro Woman Namid daphaey as Long as She Lives and after hir Death the S. Negro daphney and hir Increase to be dividid Equally between hir Children Item I Give to my daughter Salley and hir husband Henry Birdsong one Shilling Each Which is all that I do alet for them I also Constitute and appoint my two Sons to wit Woodson Rountree and Willim Rountree My hole and Sole Executors of this My Last Will and testament Sind Seald and delverd in the present of us this twenty fourth day of December one Thousand Seven hundred and Ninety Seven. where unto I have Set my hand and fast my Test

before his death on the 24th day of December last before he signed his will which will was afterwards signed he said there was one thing which was not mentioned in writing in his will that was some money - part of which was in the Desk and a part in the Hands of John Parham but says he that makes no odds for I alot and intend that money to the payment of all my debts I am Oweing in this world those words was spoken by Turner Rountree before he signed his will which will was after wards signed by him and we were witnesses to the same given under our hands this twenty first day of June 1798.
