or Lad Named Ralph -

Item I give & bequeath to my Son Jas. Farr one Negro boy or Lad
Named Realem -

Item I give and Bequeath to my Son Thos Farr one Negro Boy Named
Limrick -

Item I give and bequeath to my Son Jno Poolekie Farr one Negro
boy Named John -

Item I give and bequeath to my Son Titus greens Farr one Negro
boy Named Wonser -

Item then after the Decease of my beloved wife Eliza Toliaferro
Farr or her Inter Marriage, I will & Require that all my Estate

holy & Solely Except my Land, to be Equally divided - between
my Eight Children w^m B Farr Jo^e Farr The Farr Jno P. Farr
S. Farr Elener Thomas Farr, ann Keneheloe Farr and Eliz^e Francis
Farr, and all my Lands, Equally Devided between w^m B Farr Jo^e

Item I will and Require, that the Labour of my Negeors^t Produce
of my Lands, go to Maintain & School my Eight children, w^m B.

if any Remainder to be yearly Divided between my five sins Last
Named - and I the sd w^m Farr do publish Pronounce and Declare
this to be my last Will and Testament, Revoking Disannulling
and Disallowing, all Former Wills and Testaments made by me,
and this only tobe my Last Wills and Testaments made In Witness
Where of I have here unto Set my hand and Seal this 35th of
July 1792 -
