Croft, the Son of My Deceased Niece Lydia Croft to them during there lives and their deaths to the issue of there bodys but should either of them die without lawful issue then to be disposed of as they may think proper my desire and Intention is, that should Benjamin S. Croft not live to the age of twenty One or leave lawful issue then and in that case the Property which I have bequeathed him shall

(Item Fifth) It is my will and desire that the following named Negro's, Hercules, Taffey, William, Carolina, Sharlo, Phebe, Melia, Leah, & Henry, my Stock of Cattle and Sheep and every other articles not mentioned, be equally divided between my Nephew Henry Lenud and My Niece Maria McAllister and Benjamin S. Croft, the Son of My Deceased Niece Lydia Croft to them during there lives and their deaths to the issue of there bodys but should either of them die without lawful issue then to be disposed of as they may think proper my desire and Intention is, that should Benjamin S. Croft not live to the age of twenty One or leave lawful issue then and in that case the Property which I have bequeathed him shall be equally divided between my Nephew Henry Lenud and My Niece Maria McAllister or their lawful begotten issue-----
