being weak and feeble In perfect memory and sound mind calling to mind that all man kind was born to die I do make this my last will and Testament to wit first of all I recommend my body to The ground to be buried in a Christian like manner and my soul to God who gave it and as for what worldly goods it hath pleased God to bless me with I give and dispose of In The following manner

Item / I give and bequeath to my beloved grand daughter Ann Buddin one negro girl named Rose and The one fifth part of all The rest of my negroes to wit Cotto, Nacey and her child John, Amy, Billy, Silvia, Tommy, Joe, Clarendor, Saby, Tisty and the fifth part of my stock and house hold and Kitchen Furniture to her and her Lawful begotten children

Item 2 It is my will and desire That all The rest of my Estate after my funeral Expences and all my Just debts is paid, Shal be equally Devided share and share alike between my five grand children namely John Lequeuse, James Buddin, Solomon Buddin, Ann Buddin, and Martha McCall to them and their Lawful begotten Children

Item 3 it is my will and desire that if any of Those my grand children should die with leaving living children or there Issue Then In that case that part so devised to the deaseast to return back and be Equally devided share and share alike to my surviving grand children or their Lawful Issue

Item 4 it is my will and desire that all The property Except Buddin my grand daughter

this my will and testament I do hereby give and bequeath (1820-1841) recom-
mend my body to the ground to be buried in a Christian like

Item 2 It is my will and desire That all The rest of my

my five grand children namely John Lequeuse, James Buddin,
Solomon Buddin, Ann Buddin, and Martha McCall to them and
their Lawful begotten Children

Item 3 it is my will and desire that if any of Those my
grand children should die with leaving living children or
there Issue Then In that case that part so devised to the
deseast to return back and be Equally devided share and
share alike to my surviving grand children or their Lawful
Issue

Item 4 it is my will and desire that all The property Except
Rose which I have bequeath to Ann Buddin my grand daughter
shall remain to gether till all my Just debts is paid Then to
be divided as I have before Devised and John Lequeuse, James
Buddin, Solomon Buddin and Martha McCall shall Receive Then
Their part and Ann Buddin shall receive her part when she
comes to the age of twenty one years or at The day of mar-
riage and I do constitute make and and appoint my friend

Peter E. Perritt my soul Executor in manner and form above written

Item 5 it is my will and desire that all my Estate be divided as I have before directed by Three Free holders of This neighbourhood to be chosen by my Executor Peter E. Perritt without any order from any court In this state

Item 6 it is my will and desire That if any of The above named John Lequeuse, James Buddin Solomon Buddin, Ann Buddin and Martha M^cCall Resuse to divide my Estate in manner and form as I have directed Then That one of Them so Refusing to divide shall have but Five shillings of my Estate and The rest of That part devised to Them so refusing shall be Divided Equally between The rest of Them That does not Refuse
