Its my will & desire that all the personal property that I have received from the Est of Mo Jms Burrows my wifes father & from the Est of her Brother George Burrows & likewise all that may hereafter fall to me from the relatives of my wife Either ~~real~~ or personal shall be equally divided between my wife Mary Hewit & her Children by me share & share alike & in case aney of my Children should die before they arive at age or marry that their share be equaley divided between my wife & the surviveing children by me. All my lands I wish to be equally divided between my Sons & in lue of my daughters shares of lands I wish Each of them to have one hundred dollars paid to them by my sons at my daughters marriage or coming to age In case aney of my sons should die before they arive at age or marry its my desire that their part of lands shall be appraised & should my surviveing Sons or son ^{Chuse} ~~Issue~~ to take itat the appraised them to have it & pay in to ^{all} the other heirs should they not take it at the ~~first~~ appraisement it to be sold & the money to be equally divided ^{all} among my surviveing heirs, I also wish Phillis and her present and future Issue to be equally divided between my wife & her children by me & if aney of my children die before they marry or come of Age that Childs share of Phillis & Issue to be equally divided between my wife & all my children- I wish my

Mailveen & H McCutchen Executors to thas my last will & testa-
ment in testamony whereof I have hereto set my hand & seal
this 16 January in the year of our Lord one thousand Eight
hundred & Sixteen & the Fortyeth year of the Indapendance
of the United States of America-----
