GEORGE GREEN

In the name of God Amen. I George Green of the district of Williamsburgh in the State of South Carolina Planter, being in health of body and sound mind memory and understanding praised be God for the same do make this my last will & testament in manner and form following. viz.

Item 1st I give devise and bequeath unto my Daughter Elizabeth M Finch one dollar & fifty cents as her share of my estate both real and personal.

Item 2nd I give devise and bequeath unto my Daughter Susanna E. Green one dollar and fifty cents as her full share of my estate both real and personal.

Item 3rd I give devise and bequeath unto my son Robert B Green the sum of one dollar & fifty cents as his full share of my estate both real & personal.

Item 4th I give devise & bequeath unto my daughter Ludicey C. Fitch one dollar & fifty cents as her full share of my estate both real and personal.

Item 5 I give devise and bequeath unto the Daughter which my present wife had previous our marriage one cow & calf as her full share of my estate both real & personal.

Item 6th to my present wife Susannah Polley Perneel Green & all the children she may have to me I give devise and bequeath the whole or remainder of real and personal estate and effects of what nature or kind soever to be equally divided share & share alike when the children arrive to lawful age it is also my wish that my present wife shall live on & plant any part of my lands she may wish during her life.

Item 7th should all of my children by my present wife

Item 1st I give devise and bequeath unto my Daughter Elizabeth M Finch one dollar & fifty cents as her shull share of my estate both real and personal.

Item 2st I give devise and bequeath unto my Daughter Susanna E. Green one dollar and fifty cents as her full share of my estate both real and personal.

Item 3 st I give devise and bequeath unto my son Robert B Green the sum of one dollar & fifty cents as his full share of my estate both real & personal.

Item 4 st I give devise & bequeath unto my daughter Ludicey C. Fitch one dollard & fifty cents as her full share of my estate both real and personal.

Item 5 I give devise and bequeath unto the Daughter which my present wife had previous our marriage one cow & calf as her full share of my estate both real & personal.

Item 6 st to my present wife Susannah Polley Perneel Green & all the children she may have to me I give devise and bequeath the whole or remainder of real and personal estate and effets of what nature or kind soever to be equelly divided share & share alike when the children arrive to lawful age it is also my wish that my present wife shall live on & plant any part of my lands she may wish during her life.

Item 7 st should all of my children by my present wife die without leaving lawful issue then all of there part of my estate both real & personal to return to my son Robert B Green to be disposed of as he may think proper.

Item 8 st should my present wife die without leaving lawful issue to by me then her part of my estate both real & personal to return to my son Robert B Green to be disposed of as he may think proper

Item 9 st should the two children by my present wife live

to have a division of my lands it is my wish that my son George Deccator Green shall have the upper part or half of the land on which I live--- and I do hereby nominate constitute & appoint my said wife Palley Parnesal Green my executrix and Robert B Green & James E Fulton executors to this my last will & testament hereby revoking and making void all every other will or wills at any time heretofore by me made and do declare this to be my last will and testament. In witness whereof I the said George Green hereunto set my hand & seal this twenty forth day of July eighteen hundred & thirty eight signed sealed and declared & published by the above named George Green as and for his last will and testament in the presence of us who at his request and his presence have subscribed our names as witnesses thereto-
