

I, Hannah Chandler of Williamsburgh

District in the state aforesaid being of a sound and disposing mind and memory but weak in body and calling to mind the uncertainty of this life do make and ordain this my last Will and Testament in manner and form following  
To Wit: 1<sup>st</sup> I give and bequeath unto my Daughter Rebecca Scott and her children my Negro Man Isaac for the support and maintainance of her and her children during her natural life, at her death to be equally divided among her children share and share alike she paying over to my Executors fifty Dollars out of the valuation of said negro Isaac-----

2<sup>nd</sup>ly I give and bequeath unto my Daughter Catherine Woodburn One hundred Dollars to be paid her by my Executors herein after named.

Thirdly I give and bequeath unto my son Joseph Chandler One hundred Dollars to be paid him by my Executors.

Fourthly I give and bequeath unto my son Paul Chandler and his children the Tract of Land whereon he now resides for the support of him and his children during his natural life at his death to be equally divided among his children and Thirty dollars to be paid him by my Executors.

Fifthly I give and Bequeath unto my son George H Chandler my negro Man Sam during his natural life at his death to be equally divided among his children he paying out of the valuation of said negro Sam One hundred and Eighty dollars out of the valuation of said negro Sam to assist in paying up the legacies herein before mentioned on his receiving the said negro Sam into his possession after my death-----

I give and Bequeath unto my grand Daughter Hannah Castles Scott one Bed and furniture---

Lastly it is my Will and Desire that my negro Woman Judea should remain with my daughter Rebecca Scott during their joint lives, should she survive my said Daughter to live wherever my said Daughter should appoint for her to live

before her death, and not be considered any part of my Estate, and not to be subject to any division among my heirs nor under the control or management of my son Julian Josphah Scott. and It is my wish and desire that my Executors herein named protect the said negro woman Judea whenever It might be out of my daughter Rebecca's power to do so---

I do hereby Nominate and appoint George H Chandler and R G Ferrell my Executors to this my last will and Testament
