ISAAC MATTHEWS.

In the name of God, Amen. I Isaac Matthews of Williamsburgh District and State of South Carolina being in health of body and of sound and disposing--mind, memory and understanding, do make and declare this my last will and testament, in manner and form following; that is to say, I give and bequeath unto my Son John Matthews the following Slaves, viz March, Hannah, Brotes Waites and Sybil, And my will is that my said Son John Matthews Shall pay to each of my daughters, Ann Soreven, wife of Capt. John Soreven and Sarah Lester, wife of William Lester, one year after my decease, the sum of one hundred dollars, in liev of lands given to him, and I do hereby charge the above legacy with the payment thereof accordingly. Also, I give and bequeath unto my aforesaid daughter Ann Soreven, the following Slaves, George, Sarah, Harry, Rachel and Child David. Also the sum ~~to~~ <sup>of</sup> one hundred dollars to be paid by my son John Matthews in manner aforesaid. Also, I give and bequeath unto my aforesaid daughter, Sarah Lester, the following Slaves, Porter, Rose Milly, ClariSSa and Nat, and the sum of one hundred dollar to be paid by my son John Matthews, in manner aforesaid. Also, I give and bequeath unto my daughter Jane Matthews, the following slaves, Tom, Candy, Jack, Dinah and Child Bobin, one Bed and Bed furniture, and the sum of two hundred dollars. Also I give and bequeath unto my daughter Mary Ervin Matthews the following slaves; Joe, Flora, Jemmy, Delia, January, Rachel and Child Rose, one Bed and Bed furniture , and the Sum of Two hundred dollars. Also I give devise and bequeath all that my house or tenement, land and hereditaments, with the appurtenances whereon I now reside, consisting of seven hundred and

Brotes Waites and Sybil, And my will is that my said Son John Matthews shall pay to each of my daughters, Ann Soreven, wife of Capt. Also the sum ~~to~~<sup>of</sup> one hundred dollars to be paid by my son John Matthews in manner aforesaid. Also, I give and bequeath unto my aforesaid daughter, Sarah Lester, the following Slaves, Porter, Rose Millie, ClariSea and Nat, and the sum of one hundred dollar to be paid by my son John Matthews, in manner aforesaid. Also I give and bequeath unto my daughter Jane Matthews, the following slaves, Tom, Candy; Jack, Dinah and, Child Bobin, one Bed and Bed furniture, and the sum of two hundred dollars. Also I give and bequeath unto my daughter Mary Ervin Matthews the following slaves; Joe, Flora, Jemmy, Delia, January, Rachel and Child Rose, one Bed and Bed furniture , and the sum of Two hundred dollars. Also I give devise and bequeath all that my House or tenement; land and hereditaments, with the appurtenances, whereon I now reside, consisting of seven hundred and fifty acres, and is represented on a plat made by R. Witherpoon and dated the twenty-eighth day of August one thousand eight hundred and two, unto my son Isaac Matthews, his heirs and assigns forever; Also the following Slaves, Moses, Amaritta and their children, BeSS, Lydia, Jin, Tena, Rina and Hector, Man and child Maria, Roderick, Shadrack and Satira, also one Bed and Bed Furniture, one horse of the value of one hundred dollars and the choice of my hand Mills. Also it is my will

and desire that my negro wench, ~~John~~, have her freedom after  
my decease, and if unable to provide for herself, that she  
receive from each and every of the aforesaid legatees the sum  
of five dollars per annum, and I hereby charge the aforementioned  
legacies with the payment thereof. It is also my will and  
desire that my Executors, hereafter mentioned do, immediately  
after my decease, execute such deed of Manumission as will be  
effectual in law for the emancipation of the aforesaid Negro  
wench. All the rest, residue and remainder of my estate and  
effects, <sup>OF</sup> what kind or nature soever, which I have or shall  
have right to dispose of, I give, bequeath and devise unto my  
children, equally to be divided between them, their heirs  
executors, administrators and assigns forever. And I do hereby  
nominate constitute and appoint my two sons, John Matthews  
and Isaac Matthews and my sons-in-law John Screven and William  
Lester Executors of this my last will and testament; hereby  
revoking and making void all former wills and testaments at any  
time heretofore by me made; and do declare this to be my last  
will and testament. In Witness whereof I have hereunto set my

bequeathed to the said Isaac in my last will; And my will &  
meaning is, that this Codicil be adjudged to be apart and ppeel  
of my last Will & Testament that all things therin mentioned,  
be faithfully & truly performed and as fully & amply in every  
respect, as if the same were so declared & set down in my last  
will & Testament,----Witness my Hand & seal this seventh Day  
of October, & in the year of our Lord one Thousand Eight  
hundred & Twelve
