In the Name of God Amen; I James Gowdy of the destrict of Williamsburgh and State of South Carolina, being Very Sick & weak in body, but of perfect Sound Mind & memory, thanks be given to God for his Mercy; and calling to mind the mortality of my body, and knowing that it is appointed for all men once to die, do make and Ordain, this my last Will and testament, and first I Recommend my immortal Soul into the Arms of my Blefed Redeemer, and my Body to the Earth, to be buried in a decent Christian manner at the discretion of my Executors, nothing doubting but at the Resurection to receive the same again by the mighty Power of God, and as for such Worldly Estate wherewith it hath Pleased God to blefs me with in this life, I Give devise & dispose of the same in the Manner & form following---Impremis it is my desire that my ^{general} formal charges be paid an all my Just debts be fully paid & satisfyd, out of my Eftate---Imp., it is my Will that all my personal Eftate be sold at Public Vandue as soon as can be donee conveiniently and the money arising from the sale, to be put out at Interest for the benefit of my two children, Mary Francis Gowdy, and James Malcomson Gowdy,---Impri., it is my Will that all my lands be sold likewise at public or private Sale discretinal to my Executors, Hereby giving my Executors full power to Execute deeds to the same, and the Money Arising from the sale to be put out at Interest for the benefit of my two Children Aforesaid the money of my Eftate both Real and Personal I desire to be Equally divided between my two Children Mary Francis Gowdy, and James Malcomson Gowdy when either of them do marry, or when they arive at the age of twenty-one, but in case either of them should die before attaining the age of twenty-one years, then

to die, do make and Ordain, this my last will and testament,
and first I Recomend my immortal Soul into the Arms of my
Blesed Redeemer, and my Body to the Earth, to be buried in a
decent Christian manner at the discretion of my Executors,
