JOHN BROCKINTON.

(State of South Carolina)

In the name of God, amen

I John Brockinton, planter, of the district of Williamsburg and state aforesaid, being of sound and disposing mind and memory do make and declare this my last will and testament in manner and form following, to wit, Item 1., I give devise and bequeath unto my Loving wife my buggy and a horse of her own. Choosing from the stock that may be upon my plantation at the time of my death, also my stock of hogs with all their future increase ^{and} Item 2., It is my wish and desire that my Kind and loving wife live and remain on and have the use of the land upon which I now reside with the use of all my household and Kitchen furniture during her natural life and after her death to be disposed of herein after mentioned rd Item 3., I give devise and bequeath unto my son William S. Brockinton one mule and to reside on the place where he is now living until he can get a place to go to and when he leaves to take whatever he wishes to move with him off of the land--- th Item 4th I give devise and bequeath unto my son James F. Brockinton that portion of land on the North side of smiths swamp Known as the Dollard tract, together with the John Marshall tract of land and one mule---Item 5th I give devise and bequeath unto my son Benjamin F. Brockinton that part of the Dollard tract on the south side of smith swamp together with the tract of land Known as the Davidson Land and one mule---- Item 6th My two other sons, John Brockinton and Samuel Brockinton having already been provided for and settled by me I therefore deem it but Just and Equitable that they--the last two named have no share in the aforesaid

bequeath unto my Loving wife my buggy and a horse of her own
Choosing from the stock that may be upon my plantation at the
time of my death, also my stock of hogs with all their future
increase Item 2nd, It is my wish and desire that my Kind
and loving wife live and remain on and have the use of the land
upon which I now reside with the use of all my household and
Kitchen furniture during her natural life and after her death
to be disposed of herein after mentioned Item 3rd, I give
devise and bequeath unto my son William S. Brockinton one mule
and to reside on the place where he is now living until he can
get a place to go to and when he leaves to take whatever he
wishes to move with him off of the land--- Item 4th I give
devise and bequeath unto my son James F. Brockinton that portion
of land on the North side of smiths swamp Known as the Dollard
tract, together with the John Marshall tract of land and one
mule---Item 5th I give devise and bequeath unto my son Benja-
min F. Brockinton that part of the Dollard tract on the south
side of smith swamp together with the tract of land Known as the
Davidson Land and one mule---- Item 6th My two other sons, John
Brockinton and Samuel Brockinton having already been provided
for and settled by me I therefore deem it but Just and Equitable
that they--the last two named have no share in the aforesaid
lands---Item 7th I give devise and bequeath unto my two Daughters
viz. Martha McCollough and Mary Hanna and my grand Daughter
sarah H. Jacks the big savanna tract of land----
Item 8th I give devise and bequeath unto my Daughter Sarah
Nesmith one dollar----Item 9th I give devise and bequeath unto
my four sons John Brockinton William S. Brockinton James F. Broc-
kinton and Benjamin F. Brockinton the residue of my lands not
named in this will and plantation tools to be equally divided

Item 10 I do hereby nominate, constitute and appoint my four sons John Brockinton William S. Brockinton James F. Brockinton and Benjamin F. Brockinton my Executors of this my last will and testament

Lastly, I do hereby constitute this as my last will testament hereby revoking all former wills heretofore made by me for me at my request---
