JOHN LEGER.

In the Name of God Amen--I John Leger of the state of South Carolina District of Williamsburgh being in a poor state of Health but of perfect sound mind and memory Thanks be given to the Almighty dispenser of that blessing & Calling to mind the Mortality of this body and knowing that it is appointed for all men onst to die do make and ordain this my Last Will and Testament in the following form and manner that is to say first it is my desire that after my deceased my remains be decently interred if pearlabell in the burial ground where my Children are buried. Nothing doubting but at the general Resurrection I shall receive same again by the mighty power of God and my immortal soul. I recommend to the arms of Jesus Christ my dear redeemer and as for such worldly estate wherewith it hath pleased God to bless me with in this life I give demise and despose of the same in the manner and form following Item it is my will and strict command that after the expenses attending my funeral be fully paid and sales fixed that to my Daughter Dorothy Blakely fifty dollars per year after my decease to be paid yearly Item and all the rest of my estate both real and personal I give and bequeath to the Heirs of her body lawfully Begoten but it is my strict command that no part of my estate should be removed out of this state but shall remain on my land where I now reside under the controle of my Executors if my Daughter dorothea aforesaid should leave this state thus--- the proceeds of the said estate do be ^{Reserved} removed in the hands of my Executors untill the eldest then alive shall come of age it a son to the age of twenty one years of age and if a Daughter untill she arrive at the age of eighteen years of age then the one so arriving shall have their part by an equal division,

all men onet to use to make and ordain this my Last Will and
Testament in the following form and manner that is to say first
it is my desire that after my decessed my remains be decently in-
tered if pearlabell in the burial ground where my children
are buried. Nothing doubting but at the general resurection
I shall receive same again by the mighty power of God and my
immortal soul. I recommend to the arms of Jesus Christ my dear
redeemer and as for such worldly estate wherewith it hath
pleased God to bless me with in this life I give demise and
despose of the same in the manner and form following Item it is
my will and strict command that after the expenses attending
my funeral be fully paid and sales fixed that to my daughter
Dorothy blakely fifty dollars per year after my decease to be
paid yearly Item and all the rest of my estate both real and
personal I give and bequeath to the heirs of her body lawfully
begoten but it is my strict command that no part of my estate
should be removed out of this state but shall remain on my
land where I now reside under the controle of my executors if
my Daughter dorothy aforesaid should leave this state thus---
the proceeds of the said estate do be ^{Reserved} removed in the hands of
my Executors untill the eldest then alive shall come of age it
a son to the age of twenty one years of age and if a Daughter
untill she arrive at the age of eighteen years of age then the
one so arriving shall have their part by an equal division,
and as soon as the others come of the age above mentioned then
each of have their part of my estate and in case any of the ch-
ildren of my Daughter Dorothy aforesaid should die before they
come of age that the parts should devolve to them shall fall
to the surviving or surviving child or children of my said
Daughter, but if my Daughter Dorothy aforesaid and hir lawful
heirs of her body should die before they come of age their

part or parts and my Daughter Dorothy aforesaid should leave
no lawful heirs that then I leave all my estate both real
and personal to my cousin William Leger's Children in the West-
ern County with the same restrictions as above, Item I do
hereby nominate and appoint my trustees & friends Archibald
Campbell and Dorothy Blakley both this district to execute this
my Will and my only and sole Executors of this my last Will
and Testament utterly disowing and revoking all other Wills
by me made declaring this & this will only to be my last Will and
Testament in witness whereof I have hereunto set my hand
and seal this 2^d day of March one thousand eight hundred and
eight and in the 33^d year of the sovereignty of the United
States of America--- -----
