JOSIAH COCKFIELD

In the name of God Amen. I Josiah Cockfield of the State of South Carolina and District of Williamsburgh being weak in body but of sound and perfect mind & memory blessed be Almighty God for the same; I do make and publish this my last will & testament in the form following and as touching that slender patrimony which God hath given me concerning which I have to dispose of in the form following that is to say first I give and bequeath unto my son W. J. Cockfield one bed & furniture and three cows and calves. I have given and delivered unto my daughter Ann Jones one bed & furniture and three cows and calves; I give and bequeath unto my son J. W. Cockfield one bed & furniture and three cows & calves and one mare and colt the mare & colt I have delivered to him I give and bequeath unto my son E. J. Cockfield one bed & furniture and three cows & calves; I give and bequeath unto my son G. D. Cockfield one bed and furniture and three cows and calves and one colt named scoredouble; I give and bequeath unto my daughter Hannah Cockfield one bed & furniture and three cows & calves; I have give and delivered unto my daughter Agnes Barr before her decease two negroes aboy named Joe and a girl named Dinah and three cows & calves and one bed and furniture which I intend as her and her heirs full share of my estate; It is my will that the above named property be delivered to my children when they become of age; It is my will also that the same time that all of my personal property be appraised and equally divided in six shears or as many shears as I have living children and those that is of age to draw their respective shear and the reaminder

Cockfield one bed & furniture and three cows & calves; I give and bequeath unto my son G. D. Cockfield one bed and furniture and three cows and calves and one colt named scoredouble; I give and bequeath unto my daughter Hannah Cockfield one bed & furniture and three cows & calves; I have give and delivered unto my daughter Agness Barr before her decease two negroes aboy named Joe and agirl named Dinah and three cows & calves and one bed and furniture which I intend as her and her heirs full share of my estate; It is my will that the above named property be delivered to my children when they become of age; It is my will also that the same time that all of my personal property be appraised and equally divided in six shears or as many shears as I have living children and those that is of age to draw their respective shear and the reaminder to be kept on the plantation as the property of my three youngest children; untill E. J. Cockfield becomes of age and then the property to be appraised and equally divided in three shear and E. J. Cockfield to draw his respective shear and the remainder to be kept on the plantation as the property of my two youngest children untill L. D. Cockfield becomes of age & then the property to be appraised and equally divided in two shears & L. D. Cockfield to draw his respective shear; and the remainder

to be kept on the plantation as the property of my daughter Hannah Cockfields property untill she becomes of age and then she to get her respective shear; It is my will that my plantation on the Lake be rented out untill my youngest child becomes of age; It is my will if any of my children after they are of age & draws their shear of property wishes to continue on the plantation and work their hands I wish them to draw a share of the crop in proportion to their hands It is my will that my bay mare be kept breeding to raise a horse apiece for E.J. Cockfield and Hannah Cockfield and should they not be raised that they be furnished with a horse apiece when they become of age worth seventy five Dollars; It is my will if the colt I have given L.D. Cockfield should die before he becomes of age that he be furnished with a horse when he becomes of age worth the same amount; It is my will that all my stock of cattle and hogs should be kept on the plantation except such hogs as should be disposed of for the use of the plantation and the support of my three youngest children untill they become of age; It is my will that my daughter Hannah Cockfield after my decease be sent to a female school for the space of one year & her boarding and tuition clothing be paid out of the money that I have in hand; It is my will that if any of the horses that I leave on the plantation should die and others be bought out of the profits arising from the estate after adivison that the said horse or horses blong to my three youngest children; It is my will that the money arising from the sales of my present crops cotton & two horses and maketable hogs and such plantation tools as can be spared one wagon one wriding chair and one set of black smith tools and other articles too tedious to mention and the money arising from the sales & money

will that my bay mare be kept breeding to raise a horse apiece for E.J. Cockfield and Hannah Cockfield and should they not be raised that they be furnished with a horse apiece when they become of age worth seventy five Dollars; It is my will if the colt I have given L.D. Cockfield should die before he becomes of age that he be furnished with a horse when he becomes of age worth the same amount; It is my will that all my stock of cattle and hogs should be kept on the plantation except such hogs as should be disposed of for the use of the plantation and the support of my three youngest children until they become of age; It is my will that my daughter Hannah Cockfield after my decease be sent to a female school for the space of one year & her boarding and tuition clothing be paid out of the money that I have in hand: It is my will that if any of the horses that I leave on the plantation should die and others be bought out of the profits arising from the estate after adivison that the said horse or horses blong to my three youngest children; It is my will that the money arising from the sales of my present crops cotton & two horses and maketable hogs and such plantation tools as can be spared one wagon one wriding chair and one set of black smith tools and other articles too tedious to mention and the money arising from the sales & money I have in hand to be appropriated in paying my just debts and to the repairing my dwelling house or Build atwo story dweling house & cotton screw and to buy a horse apiece for my three minor children if needed and if they should be any over plush it be equally divided among my five named children W.J. Cockfield J.W. Cockfield E.J. Cockfield L.D. Cockfield & Hannah Cockfield It is my will that if any of my children after drawing there full share should die without lawfull heirs that there respective shares return to their living Brothers &

youngest child becomes of age that all my real estate & per-
ishable property that is land horses catttle hogs house hold
& kitchen furnature & plantation tools to be appraised & sold
& the money to be equally divided among my last named childer
or thier lawfull heirs; W.J.Cockfield Ann Jones J.W.Cockfield
E.J.Cockfield L.D.Cockfield & Hannah Cockfield and I appoint
my sons W.J.Cockfield J.W.Cockfield & E.J.Cockfield when he
becomes of age sole executors of this my last will & testament
& hereby revoking all former wills made by me in witneSs
wher of I have unto set my hand and seal this the Sixth of
sept. in the year of our Lord one thousand eight hundred &
thirty seven
