5th. I give and bequeath to my Sons David Epps Robert Epps and my daughter Jane S. Epps all the rest and residue of My part of the Household and Kitchen Furniture to be equally divided among them share and share alike.

6th. I give and bequeath Finally all the rest, residue, and
