MARTHA YOUNG.

I, Martha Young, of Williamsburgh District in the State of South Carolina, widow of Isaac Young deceased, do make, ordain and publish this my last will and testament, -revoking all other wills at any time heretofore made by me--in manner and form following, viz :

Item--I return my Soul to God who gave it, in hope of the Salvation purchased alone thro' the merits of Jesus Christ; and it is my wish that my body be decently burried at the discretion of my Executors hereinafter named----

Item--I give and bequeath to my son William C. Young One negro man slave named Hiram already in his possession also a black mare in his possession.

Item--I give and bequeath to my grand son William Henry Young the son of William C Young one hieffer--

Item--I give and bequeath to my son Samuel James Downing one cream colored mare and one cow & calf already in his possession--

Item--I give and bequeath to my daughter Agness Burns--the wife of Reason Burns--to her and the issue of her body--one tract of land of fifty acres whereon she now resides--one negro woman named Lenah & her increase--one Sorril mare with a blaze face--all my household & kitchen furniture and my stock Cattle and hogs not herein otherwise disposed of--to hold the same in such a manner that it may not be liable for the debts of her husband Reason Burns or be disposed of by him in any manner whatsoever but that she may enjoy the same during her life time as separate property--

Item-- I give and bequeath to my daughter Martha Eliza Living the wife of Jesse Living one Brown horse & chair, one bed--stead & furniture--two cows & calves (one of them already in her

Item--I give and bequeath to my daughter Agnes Burns--the wife of Reason Burns--to her and the issue of her body--one tract of land of fifty acres whereon she now resides--one negro woman named Lenah & her increase--one Sorril mare with a blaze face--all my household & kitchen furniture and my stock Cattle and hogs not herein otherwise disposed of--to hold the same in such a manner that it may not be liable for the debts of her husband Reason Burns or be disposed of by him in any manner whatsoever but that she may enjoy the same during her life time as separate property--

Item-- I give and bequeath to my daughter Martha Eliza Living the wife of Jesse Living one Brown horse & chair, one bed--stead & furniture--two cows & calves (one of them already in her possession ~~xxxxxx~~). two sows & pigs & one trunk to have & to hold the same to herself and the issue of her body--but in case she should die without issue, then it is my will that the said property should go to the children of my son Samuel James Downing to be equally divided among them share & share alike--

Item--I give and bequeath to my grand daughter Catharine Rebecca Downing the daughter of Samuel James

Downing, one negro girl named Amey & her increase--two cows & calves, one wooden Clock & one trunk; also all the cash that I may be possessed of at the time of my death to be kept out on intrest by my Executors hereinafter named until my said grand daughter shall arrive at the age of twenty one or shall marry-- and it is my will if my said grand daughter should die without issue, that the said property herein given to her, should go to the surviving children of my said son Samul James Downing to be equally divided among them share and share alike--

Lastly I nominate and appoint my friends Peter B. Mouzon and James L. Mouzon Executors of this my last will and testament hereby revoking all former wills at any time made by me--In testimony where of I have hereunto set my hand & seal to be wit my hand of each at the bottom of the two first pages and my hand and seal this last page this eighth day of October ~~in~~ A.D. eighteen hundred and forty one--
