Item, I give and bequeath to my nephew Joseph Parsons, his Executors administrators and assigns, my Bed and furniture, if he comes back from the Western Country, and if he never comes, to his Brother David Parsons Junior, forever. Item, I give and bequeath to my niece Mary McDonald, the sum of one Dollars, forever. Item, I give and bequeath to my nephew David Parsons Junior, his Executors administrators and assigns all my Land together with the remainder of my household and kitchen furniture, not herein before given and disposed of, forever. Item, I give and bequeath unto my Brother David Parsons Senior, and my nephew David Parsons Junior, their executors administrators and assigns, whatever Crop I may have to be equally
