to hir and to the lawfull heirs of hir body for ever

I give to my Daughters Sarah Hannah my Negroe Girl Amarit-
ta to hir and to the lawfull hiers of hir body for ever

I give to my Son William Banister my Negroe Boy Jefferry
to him and his lawfull Children forever

I give to my Son Robert my Negroe Boy Jimmy to him and his
lawfull Children for ever

The balance of my Estate I will to be equally devided betw-
