I commend my Soul to Almighty God. and direct that my body be decently intermed at the discretion of my wife and children. in a Christianlike manner. & that my funeral be conducted in a way corres ponding with my estate & situation in life. - And as to such worldy estate as it hath pleased God to intrust me with, I dispose of the same as follows. First. I direct that all my debts & funeral expenses to be paid as soon after my decease as possible out of the first monies that shall comein to the hands of my administrator or administrators. (with my will annexed) from my estate. - Also, I give and bequeat \ to my beloved wife Charlotte Bennett such of my household and kitchen furniture as she may select not exceeding one half of the whole according to its true valuation. Also my Barouche & harness. my gig & harness, also her choice of any two of my horses, also two cows and two calves or yearlings, or calves & yearlings. also 2 four year old steers, 2 three year old steer- 2 two year old steers and the stock of hogs and poultry which I may own at my decease to her and her Heirs forever. and relative to her expectations from the estate of her father Peter Michau (lunatic) it is my will that my said wife should have the whole of the same. to her and her heirs forever- I also will and bequeath to my wife all the land I now own to her profess use during

Cantey & Samuel E. Graham to be trustees in trust of so much of my property as is now bequeathed & may yet come from my estate to the said Charlotte Louisa Gordon & her lawful Ksue.

It is likewise my will as I have attempted to express it that the lawful issue of any of my above named daughters who shall have died before the time where any of the proper tyherein above mentioned should be coming to those shall be entitled to such share or shares part or parts as their respective mother or ancestors should have been entitled to receive of them living, and that the share of my real & personal estate was above bequeathed & limited to my said wife shall be in lieu of her dower at Common law not to be subject to the sisposal or debts of her husband or husbands should she again mary and I also hereby appoint the above named W.I.R. Cantey & Samuel E. Graham to be Trustees in trust of so much of my estate as is by this will bequeathed to my wife. In witness whereof I Samuel Bennett have to this my last will & testament contained in this sheet set my hand and seal this ninth-day of Marchone thousand eight hundred and forty two in the sixty sixth year of American Independence
