Samuel Spry Montgomery of the State and District aforesaid, (Planter,) being weak in body, but in the full exercise of my reason and Memory, Thanks be to God for his mercies, and calling to mind the mortality of my body, and Knowing that it is appointed for all Men once to die, do make and appoint this my Last Will and Testament.

First, I give and bequeath to my dearly beloved Wife Frances Ann Montgomery the following negroes Viz: Rachel and her children Richald, Sampson, Lucy, Joe, April, Riley, Essex and Adam, Woman Mary, Jessee, Bine, William, Nancy and Phillis together with their future Increase and Issue.

Second, I give and bequeath the remainder of my negro property with their future Increase and ISsue to my beloved Sons and Daughters, Samuel Edgar, Jane Agnes, Isaac, Frances Elenor, Mary Emily and an unborn infant or infants, (as the case may be,) to be equally divided between them as they shall come of age or Marry.

Third, I give and bequeath the stock of all discriptions, Plantation tools, Household and Kitchen furniture &c to my beloved wife Frances Ann and my beloved children Samuel Edgar, Jane Agnes, Isaac, Frances Elenor, Mary Emily and an unborn infant or infants (as the case may be,) to be equally divided among them as they respectively arrive to years of maturity or marry, and my beloved wife to draw her portion wherever she may desire the same.

Fourth, I will the plantation on which I reside and also the tract of land on which Mr Ebenezer Martin now lives, (which land I purchased at Sheriff sale,) together with all lands now claimed by me

be undivided, and the childrens property Kep together until they

Third. I give and bequeath the stock of all discriptions, Plantation tools, Household and Kitchen furniture &c to my beloved: wife Frances Ann and my beloved children Samuel Edgar, Jane Agnes Isaac, Frances Elenor, Mary Emily and an unborn infant or infants (as the case may be,) to be equally divided among them as they respectively arrive to years of maturity or marry, and my beloved wife to draw her portion wherever she may desire the same . Fourth, I will the plantation on which I reside and also the tract of land on which Mr Ebenezer Martin now lives, (which land I purchased at Sheriff sale,) together with all lands now claimed by me be undivided, and the childrens property Kep together until they marry or arrive at age, -- reserving to my beloved wife Frances Ann , her living on the said plantation with use of any part or portion of said lands during her life time, and at her death said that lands to be devided as equally as Practicable between my three surviving sons and Daughters, as they respectively arrive of age, and should my beloved wife die before any of my children become

of age, then the said plantation be still kep up, and the same disposition made as above stated, as the Heirs successively arrive to years of Maturity or Marry.

Fifth, I will and desire, that my sons and Daughters, be educated our of the proceeds, made on the plantation, by the undivided property left to my beloved Children.

Lastly, I do hereby nominate, constitute and appoint my beloved wife Frances Ann, Executrix; and my beloved sons Samuel Edgar, and Isaac, (when they become of age) Executors of this my last Will and Testament. ----And I do hereby Revoke and Disannul all and evry other Former Will and T estament by me made, and Confirm this as my last Testaments.
