SARAH M. LOWRY

In the name of God Amen. I Sarah M. Lowry being weak in body but of sound mind and memory do make this my last Will and Testament in the manner following to wit. It is my will and desire that after my just debts are paid that my property be equally divided between my three children John Alexander Burgess Lowry , Christina Elizabeth Lowry and Sarah Caroline Witherspoon Lowry share and share alike and should either of my children die without leaving issue the property to return to my other child or children that may be living but should they all die without leaving issue then it is my will that James Scott daughter Ann Sinclair shall have my negro Woman Maggy and her increase that Albert Scotts daughter Ann Sinclair shall have Alvenia and her increase that William Scotts son David Lowry shall have my negro woman Jennet and her increase and that John T. Scott to have the balance of my negroes, Patsy, Stephen Davy old Peg and Robert, it is also my will and desire that my negro boy Henry be sold by my Executors to pay my just debts it is also my will and desire that my Executors sell of my household and Kitchen furniture and stock without applying to the Ordinary or any other Court and should either of my children my marry or come of age to the age of twenty one that my Executors shall call in three or five men and divided the property and give of to the one that marries or arrives to the age of twentyone his or her share of the property without applying to any court of law or Equity-lastly I do nominate and appoint my Uncle Joseph Scott Sen. and John T. Scott my Executors to this my last will and testa-

my property be equally divided between my three children John Alexander BurgeSs Lowry , Christina Elizabeth Lowry and Sarah Caroline Witherspoon Lowry share and share alike and should either of my children die without leaving issue the property to return to my other child or children that may be living but should they all die without leaving issue then it is my will that James Scott daughter Ann Sinclair shall have my negro Woman Maggy and her increase that Albert Scotts daughter Ann Sinclair shall have Alvenia and her increase that William Scotts son David Lowry shall have my negro woman Jennet and her increase and that John T. Scott to have the balance of my negroes, Patsy, Stephen Davy old Peg and Robert, it is also my will and desire that my negro boy Henry be sold by my Executors to pay my just debts it is also my will and desire that my Executors sell of my household and Kitchen furniture and stock without applying to the Ordinary or any other Court and should either of my children my marry or come of age to the age of twenty one that my Executors shall call in three or five men and divided the property and give of to the one that marries or arrives to the age of twentyone his or her share of the property without applying to any court of law or Equity- lastly I do nominate and appoint my Uncle Joseph Scott Sen. and John T. Scott my Executors to this my last will and testament made this twenty sixth day of March in the year of our Lord One thousand eight hundred and forty four and the sixty Eight year of the American Independence
