And as Touching such Worldly Estate wherewith it hath pleased God to Bless me with herein this life; I devise and Bequeath in manner and form Following. That is to say, I order all my just debts and Funeral charges to be paid out of my Estate. I give devise and bequeath to my Nephew John Watson a Tract of Land lying on Thorntree Swamp and District aforesaid, Also six Negroes, Viz Rose and her two children Binkey & Infant, Friday, Jack & Peter, also Two Beds and Furniture; Stock of Black Cattle, 1 Black mare named Jinny and the stock of Hogs. I give devise and bequeath to my Niece, Sarah Ann Watson, Four Negroes, Viz Molly Joe, Hannah, & Venus; also one Bed and Furniture. I give devise and bequeath to my Brother John Watson one Tract of Land Situate in Sumter District containing eighty three & one third Acres. Also seven Negroes Viz, Binkey, January, Sam, Kelly, Florah, Phebe, & Mary. And all the rest of my property consisting of Household & Kitchen furniture together I give devise & bequeath to be equally
