State of South Carolina.

In the name of God Amen. I Susannah Graham of Wmsburgh
~~istrict & State of~~ said being weak in body of sound &
disposing mind & memory thanks be to Almighty God for the
same Do make & ordain this to be my last will and Testa-
ment in manner & form as follows. First I give & bequeath to
my Daughter Sarah E. Cade Two negroes (viz) Back & Girl
Caroline & the future increase of said Girl Caroline, Two
Cows & Calves & one feather Bed, during her natural life at
her death to be equally divided among her Issue & not to be
subject to her husband or husbands debts in any way now at
their control but to remain in charge of the Trustees whom
I shall appoint & I do hereby nominate constitute & appoint
My Son John F. Graham & my Grandson WM. G. Cade as Trustees
over the said portion of property which is her full share of
my Estate.

Second I will & bequeath To my Daughters Mary T. Frierson,
Jinnet M. Cockfield & Susanne E. Frierson & my Sons A.F.
Graham Saml. E. Graham, William I. Graham, I.F.Graham,
D.B.Graham & A.W.I.Graham the remaining portion of my pro-
perty after my debts are paid

Third I will & bequeath to my daughters I.M.Cockfield &
S.K.Frierson one Feather bed each to be taken at the apprai-
sement as a part of their share I wish the portion that falls
to my daughter Mary T. Frierson to be paid to her in person
or to her order, or Attorney if she is living If not to be
equally divided between the Issue of her Body If they call
for it in Five years & ~~and~~ should they not call for it. It

same do make & ordain this to be my last will and Testament in manner & form as follows. First I give & bequeath to my Daughter Sarah E. Third I will & bequeath to my daughters I.M. Cockfield & S.K. Frierson one Father bed each to be taken at the appraisement as a part of their share I wish the portion that falls to my daughter Mary T. Frierson to be paid to her in person or to her order, or Attorney if she is living If not to be equally divided between the Issue of her Body If they call for it in Five years & ~~the~~ should they not call for it. It is then to be equally divided among my living children & the Issue of the dead ones, each ones Issue being entitled to the portion of their parents I also wish the whole of my property to remain together until my son A.W.I. Graham dies or recovers his health & should this negro Girl Carolina die before the division takes place then my daughter Sarah E. Cade shall receive an equal portion with the rest & it to remain in the hand of the Trustees for this benefit as

asbefore said Lastly I nominate constitute & appoint my son John F. Graham my Executor to this my last will & Testament, ~~revoking and making void all other former wills made by me & confirming this my last will and Testament~~

In witness whereof I have hereunto set my hand ~~Seal this~~ this 22nd 1847 day of November In the year of our Lord one thousand eight hundred & forty seven & the Seventy second year of American Independence Signed, Sealed & proclaimed in the presence of us
