In the name of God Amen This Twenty first of February in the year of our Lord one thousand eight hundred and sixteen, I Thomas McCrea Jun^r of the State of South Carolina Williamsburgh district, Being weak in body but of sound mind memory and understanding thanks be to God therefore, but calling to mind the mortality of my body and knowing its apointed for all men once to die, do make & ordain this my last will & Testament that is to principally & first of all I give & recommend my sole to Almighty God that gave it & for my body I give & recommend it unto the earth to be burried in a decent Christian like manner at the discretion of my Executors herein after named, & as for my worldly Estate wherewith it has pleased God to blesse me with in this life I give & dispose of the same in manner & form following That isto say my funeral charges & all my lawful & just debts be paid in a convenient time after my death--- Item I give & bequeath unto my dear & beloved wife Mary McCrea nine negroes named Harry, Young Cate, old Cate, Minda, Lydia, Jean, Dublin, Lucy, Doll, with their future increase also one bed & furniture, one Horse named Pitcher also one third part of my Household & Kitchen furniture to her & her heirs forever--- Item It is my will & pleasure that the remainder & residue of my negroes not named above shall be equally divided between my three children Mary, Ann Subannah, & Thomas Armstrong, as they arrive to the age of twenty one years or marriage, but in case any of my Three children should die before they arrive to the age of twenty one years or marriage, it is my desire that their part or share shall be equally divided amongst my surviving

for all men once to die, do make & ordain this my last will
& Testament that is to principally & first of all I give &
recommend my sole to Almighty God that gave it & for my body
I give & recommend it unto the earth to be burried in a decent

named above shall be equally divided between my three chil-
dren Mary, Ann Susannah, & Thomas Armstrong, as they arrive
to the age of twenty one years or marriage, but in case any
or my three children should die before they arrive to the age
of twenty one years or marriage, it is my desire that their
part or share shall be equally divided amongst my surviving
children---Item I give & bequeath unto my son Thomas Arm-
strong all my real Estate to him & his ASsigns forever but in
case he should die before he arrives to the years of twenty
one, it is my desire that that the land shall be equally
divided between my two Daughters or their Issue--- Item It is
my will and desire that all the remainder & residue of my
personal estate wheresoever lying & wheresoever found shall be
equally divided between my three children Mary Ann Susannah
& Thomas Armstrong at the age of twenty one years or marriage
