WILL OF
WILLIAM I. BUFORD

In the name of God Amen. I William I Buford of Williamsburgh District state of South Carolina, planter, being of sound mind memory & understanding do make publish & declare this my last will and testament in manner & form following- Item first, I give & bequeath to my wife Elizabeth my Weetee tract of land, in lieu of the Waccamaw tract of land that I sold & which by a marriage settlement went to the longest liver.

Item 2nd. I give to my wife my mulatto woman Mary and her six children, to wit, Trent, Nathan, Susan, Robert, William & Julia & their future increase (on condition) that my wife pay all my just debts and to be in lieu of any property which I may have sold under marriage settlement made between us----

Item 3d It is likewise my will and desire that my wife enjoy all the profits arising from all lands & negroes which I may be possessed of at my death during her life & that she have the privilege of selling the same or any part thereof (Except such negroes as shall be hereafter ordered not sold) and the money arising from the sale of land or negroes to be placed in Bank stock or other stock or loaned out at interest, & the interest arising from said sale shall be hers during her life to spend the same as she may think proper--

Item 4th It is also my will and desire that my wife shall have during her life, all my household & kitchen furniture all my stock of horses, mules, cattle, sheep, hogs & goats- carts, waggons, bonds or notes and every other article or thing which may belong to me at my death (The same to keep at the arrangement made & rendered to the ordinary) or to

Item 2nd I give to my wife my mulatto woman Mary and her six children, to wit, Trent, Nathan, Susan, Robert, William & Julia & their future increase (on condition) that my wife pay all my just debts and to be in lieu of any property which I may have sold under marriage settlement made between us—

Item 3^d It is likewise my will and desire that my wife enjoy all the profits arising from all lands & negroes which I may be possessed of at my death during her life & that she have the privilege of selling the same or any part thereof (Except such negroes as shall be hereafter ordered not sold) and the money arising from the sale of land or negroes to be placed in Bank stock or other stock or loaned out at interest, & the interest arising from said sale shall be hers during her life to spend the same as she may think proper—

Item 4th It is also my will and desire that my wife shall have during her life, all my household & kitchen furniture all my stock of horses, mules, cattle, sheep, hogs & goats—carts, wagons, bonds or notes and every other article or thing which may belong to me at my death (The same to keep at the appraisement made & rendered to the ordinary) or to return at her death, household & kitchen furniture & stock of all kinds, & every other article or thing which she may have received of equal value, or to sell the same or any part thereof and the money arising from said sale to be vested as stated before in Bank or other stock, or loaned out at interest, & the interest arising from the same to be applied to her own proper use but the principal to return to my estate and be disposed of as I shall hereafter direct—

Item 5th At the death of my wife it is my will and desire that my niece Elizabeth A. Gordon during her life or widowhood have the following negroes, viz, Louisa & her six children, James Aaron, Job, Harvey, Ben & Moses—If my niece Elizabeth should die before my wife, or marry, then the above negroes to go to the children of her deceased husband Alister Gordon.— Item 6th At the death of my wife I give to Frances Emma Gordon daughter of my niece Elizabeth A. Gordon the three following negroes viz Statirah, sary, & Maria, If Frances Emma should die before she becomes of age or marries the said negroes to be equally divided between the surviving children of Alister Gordon— Item 7th I give to Mary Jane Anderson if living at the death of my wife one mulatto woman named Charlotte with her increase if any to her and her heirs forever— Item 8th It is my will and desire that the above negroes named in Items second, fifth, sixth & seventh shall not be sold— Lastly It is my will & desire that at the death of my wife the following negroes to wit, Jaenette, Thomas, Chloe, June, Capres, Chloe's daughter name unknown Billy, Bristow, Amelia Abel or the amount for which they have been sold— my eight tracts of land or the amounts for which they have been sold, my household and kitchen furniture or the amounts for which they have been sold and all other property not disposed of above, shall be divided into five equal portions one of which shall be given to Elizabeth A Gordon for her use during her life or widowhood & at her death or marriage to go to her the children of Alister Gordon, one to Lydia C B Richardson, one to Susan Emma Richardson, one to Samuel Clegg Chovin Richardson and one to

negroes to go to the children of her deceased husband Alister Gordon.— Item 6th At the death of my wife I give to Frances Emma Gordon daughter of my niece Elizabeth A. Gordon the three following negroes viz Statirah, sary, & Maria, If Frances Emma should die before she becomes of age or marries the said negroes to be equally divided between the surviving children of Alister Gordon— Item 7th I give to Mary Jane Anderson if living at the death of my wife one mulatto woman named Charlotte with her increase if any to her and her heirs forever— Item 8th It is my will and desire that the above negroes named in Items second, fifth, sixth & seventh shall not be sold— Lastly It is my will & desire that at the death of my wife the following negroes to wit, Jaenette, Thomas, Chloe, June, Capres, Chloe's daughter name unknown Billy, Bristow, Ameliad Abel or the amount for which they have been sold— my eight tracts of land or the amounts for which they have been sold, my household and kitchen furniture or the amounts for which they have been sold and all other property not disposed of above, shall be divided into five equal portions one of which shall be given to Elizabeth A Gorden for her use during her life or widowhood & at her death or marriage to go to her the children of Alister Gorden, one to Lydia C B Richardson, one to Susan Emma Richardson, one to Samuel Clegg Chevin Richardson and one to John Manly Richardson— I do hereby nominate constitute and appoint my wife Elizabeth Executrix to my estate during her life after her decease I nominate constitute and appoint nephews John T. Richardson, James S.G.Richardson and Peter W. Fraser, executors of this my last will and testament— In witness whereof I have hereunto set my hand & seal this thirteenth of July in the year of our Lord one thousand eight

hundred & forty five—and the seventeenth of the American
Independence—
