In the name of God Amen---I William Hanna being at present in sound mind and memory, thank God for his mercies, Do make this) my last Will and Testament-----

Item, I give to my Wife Sarah and my son James Edward my negro man Davy and negro girl Patty and negro woman Peg and Eveline and Neley and Martha and Muldro and little John and there Increase, and my Gramar and my Gigs and ten Cows and calves and bed and furniture----And it is my wish that my wife Sarah have the use of my house to live in that I am now living in During her life and land to farm on and plant and timber &c.---Item--2 I give to my other six Children, John and William and Sarah and Leddy and Julius and Zeno, my negro man Ben and Lena and Frank and King and Antony and old Sam and Mindo and young Sam and oald Dina and Linda and Sena and Pheb and Zina and George and Ephrim and Emma and Dina and Jrey and Harrey and Jacob and Little Phib, and there increase to be equally divided between the above

named six children, but if either of them should ^{twenty} die before they marry or come to the age of ~~thirty~~ one there part of the above mentioned property to be equally divided among my Children that is then living---Item 3,, it is my wish that all my property be ^{until} kept on my plantation together and work there ~~until~~ my children may or come to the age of twenty one then as they marry or come of age there part of property to be given of to them-----
