Know all persons whom it may concern that I William
Christie of Berk County in the State of Georgia Planter
for and in consideration of the sum of Thirty Five Pounds
Sterling of good and Lawful Money of Great Britain
to me in hand paid by John Collins of the State of
South Carolina Winton County, the Receipt whereof
I do hereby acknowledge have bargained sold delivered
and by these presents according to the due form of Law,
do bargain, sell and deliver unto the said John Collins
one likely Negroe Fellow Named Quanco and one
likely Negro Girl Named Pips daughter to the said
Fellow to have and to hold the said bargained Premises
unto the said John Collins his Executors Administrators
and assigns for ever and I the said William Christie
for myself my Executors Administrators the said
bargained Premises unto the said John Collins his
Executors Administrators and assigns against all
persons shall and will warrant and for ever defend
by these presents; provided nevertheless that if I the said
William Christie my Executors Administrators or assigns
or any of us do and shall and truly pay or cause to
be paid unto the said, John Collins his Heirs Executor
Administrators or assigns the sum of Thirty Five
Pounds as principal and Interest Lawful Money of
great Britain on the first Day of November next
ensuing the Date hereof for redemption of the Premi-
ses; then this present Bill of sale be void and of no effect.
But if default be made in the Payment of the said
Thirty ~~Pounds~~ Five Pounds in part or in the whole
contrary to the manner and form aforesaid that then
it shall remain and be in full force and virtue. In
Witness whereof I have hereunto set my hand and
Seal the first Day of November in the Year of our
Lord 1786.
