

STATE OF SOUTH CAROLINA

In the name of God amen I Abriham Green of the State of South Carolina and District of York being weak in body but of Sound and disposing mind Memory and understanding praised be God for the Same, do make and declare this my last Will and Testament in Manner and form following that is to say, After funeral expences and all my Just debts are paid --

(first) I Give will and bequeath unto my beloved Wife Hannah Green one third part of all my Lands in Cluding the plantation and dwelling house where I now live during hir natural lifetime-- Also one third part of all my personal estate to hir or hir assigns for ever to despose of as she thinks proper--

(second) I Give will and bequeath unto my two daughters Elisa Green and Luvisa Green all the remainder of my estate boath real and personal except such part as shal be here in after other wise bequeathed to them and the heirs of their boddy for ever to be eaqually divided betwixt my two daughters Elisa Green and Luvisa Green in manner and form following that is to say I request that all my property boath real and personal (except Notes bonds Book accounts and ready money which is to be collected and such part as is not other wise bequeathed to be put to intrest for the purpose of educating my two daughters Elisa Green and Luvisa Green at the desoresion of my Executors) shal stand as it now Stands with my wife Hannah Green and my two daughters Elisa Green and Luvisa Green until one of my daughters shal arrive to the age of twenty one years or one of my three legatees marries then a divide to take place in this way all of my estate boath real and personal shal be Valued by three free hoalders apointed and Sworn for that purpose and to be eaqually

divided in such manner as my Executors think proper--

(third) I also give will and bequeath unto Daniel Smith and George Carruth three hundred dollars to be equally divided between them as Compensation to them for serving as executors on this my last will and testament, I also empower my Executors at any time they may Consider and agree that there is any Parishable property which is not proper to ceap on the farm for them to put it to sale for the use of all my lagetees and if there at any time appears to be any more Slaves than appears to be necessary to Cultivate the preasant farm they may be put to hire and the money put to the same use--

And I do nominate constitute and apoint Daniel Smith and George carruth Sole executors of this my last will and testament hereby revoking and making void all and every other will or wills at any time heretofore by me made; and do declare this to be my last will and testament. In witness whereof I the said Abraham Green have here unto set my hand and seal this Ninth day of November in the year of our Lord 1818--
