In the name of God Amen, I Akillas Holt of the State of ~~South~~
~~Carolina~~ and district of York, being of sound and disposing mind
and memory but weak in body, and calling to mind the Uncertainty
of life, and being desirous of disposing of all such worldly
estate as it hath pleased God to bless me with, do make and or-
dain this my last Will in manner following--That is to Say---I
give and Bequeath to Seven of my children (To wit) John Holt,
Abraham Holt, Thomas Holt, James Holt Elisabeth Holt, Lucy Holt,
and Catherine Holt.---Two negroe men named George and Dave, the
above negroes to be sold by my executor and Exeuctrix on a credit
of Twelve Months, and the money arising therefrom to be equally
Divided, share and share alike amongst the above named seven
children-----

I give and to my Son Allen Wylie Holt---Seventy Acres of Land,
more or less lying in the district aforesaid on the East side
of Bufflo Creek

I give and Bequeath to my beloved Wife Jane Holt, two negroe men
named Jack and Benall Household and Kitchen Furniture, stock
and farming utensils during her Natural life and to dispose of
the same equally to her two Daughters (To Wit) Eliza Jane and
Martha Wylie, at such time as she deems proper and that my said
wife has the privilege to live on the land; whereon we now live
during her natural life The remainder of my real Estate being
a tract of Land lying in York district South Carolina--on the
Waters of Buffalo Creek, containing Five Hundred Acres more or
less. I give and Bequeath to my two Sons (Viz.) Allen Wylie Holt
and Akillis G. Holt, to be equally divided amongst them share and

share alike----

And lastly I do constitute and appoint Samuel Wylie Executor
and my beloved Wife Jane Holt Executrix of this my last Will and
Testament Ratifying and confirming this and no Other to be my
last Will and Testament-----

In Testimony whereof I have hereunto set my hand and affixed my
seal this Fifteenth day of August in the Year of our Lord, one
Thousand eight Hundred and Thirty eight-----

Codicil

Whereas I, Akillas Holt have made and duly executed this my last

of Land more or less lying in the district aforesaid on the East
side of Buffalo Creek, Now I do hereby revoke and make void the
said Legacy so far as regards the said piece or parcel of Land,
and in lieu thereof do give to my said Son Allen Wylie Holt one
Hundred dollars and do hereby direct my executor and executrix
to pay to to him the aforesaid sum of one Hundred Dollars-----
