

In the Name of God Amen I Alexander Galleway Snr. of York District State of South Carolina do make this my last Will and Testament in the following manner and form that is to say. I give and bequeath to my beloved Wife Mary a good feather bed, bed sted and furniture, a Cow and my riding Chair, her Clothes, and to have a full and sufficient support from the lands herein after devised and Given to my sons James Hugh A. and Peter W. and to be by them my three sons last mentioned provided and laid in to her my said Wife for her support and benefit. she is also to live in my present dwelling during her life or widowhood. I also give bequath and devise to my son James. that tract of Land that he now occupies adjoining Lands of James Peemster and others as laid off by platt of Survey made by John Minter containing two hundred and thirty Acres be the same more or less. one cow and calf and a feather bed and furniture to him and his heirs forever I also give and bequeath to my Son Robert Alexanders Sermons. Welwoodes Glimse of Glory one Volume of Christian Magazine a feather bed and furniture to him and his heirs forever

I also give and bequeath and devise to my daughter Margaret a tract of land on Quins Road, containing one hundred and Ninety Seven Acres as represented in a platt thereof dated Ninth of April eighteen hundred and twenty two. One Cow and calf two feather beds and the furniture she now claims. her Maxe & Saddle, to her and her heirs forever.

I also give bequeath and devise to my Son Hugh a tract of land on Quins road containing three hundred and Seven Acres and also a part of the tract laid off for my son Jonathan to adjoin

the the above tract to be laid off by a line running from the center of the line between the Sassafras and pine Corners on William Galloways land to the Center of the line between a the large pine and post oak Corner on John Galloways Land. One Cow and Calf, a feather bed and furniture to him and his heirs forever.

I also give devise and bequeath to my son Peter a tract of Land represented by a platt containing three hundred and fifty two acres, and all the residue and remainder of the tract laid off for my Son Jonothan and to be divided from the part of the land hereby devised to my Son Hugh by the line from the Centers of the aforesaid line on William Galloways Land to the Center of the aforesaid line on John Galloways Land my gray mare and Saddle, a Cow and Calf a feather bed and furniture, to him and his heirs forever. It is my will and desire that my son Jonathan at the proper expence of my Sons Hugh A. and Peter W. be put through a Collegiate education and by them the said Hugh A. and Peter W. to be furnished in Necessary books clothing and boarding during his Studies at Grammar School and College, and if the said Jonathan, whom I hereby put under the sole direction and Guardianship of my son Robert should think proper to study divinity. The said Hugh A. and Peter W. is to support him genteelly in some Theological Seminary for the space of two Years. as the price and in Lieu of the tract of Land containing two hundred and Sixty eight Acres so as aforesaid divided between them.

I also give devise and bequeath to my Grand Daughter Elizabeth daughter of my son Samuel deceased a tract of Land containing one hundred and four Acres more or less and adjoining Lands of Lucy Givens to her and her heirs forever. But if the said Elizabeth should die without lawful issue of body begotten

to my Sons William John and Alexander and my daughter Nancy the sum of one dollar as I have heretofore given them a full share of my Estate my daughter Nancy to have the tract of Land aforesaid if my Grand daughter Elizabeth should die without issue not withstanding--

I also give and bequeath the residue and remainder of my house and Kitchen furniture to my Wife and daughter Margaret to them and their heirs forever I also give and bequeath the residue and remainder of my estate. to my sons Hugh A. and Peter W. except one other cow and calf to be given by them to my daughter Margaret.

And Lastly I do hereby nominate and appoint My Sons Robert Hugh A. and Peter W. to be Executors of this my last Will and Testament hereby revoking all other former Wills and Testaments by me Made declaring this and no other to be my last Will and Testament in witness whereof I hereto set my hand & Seal this Second day of July in the Year One thousand eight hundred and twenty four.
