settling all my Worldly concerns, do, make ordain, and
publish this as My last Will and Testament

I Give and Bequeath unto my beloved Wife Elizabeth Waddel
that plantation or tract of Land whereon I now reside dur-
ing her natural life, and thereto my stepson Richard Bar-
nett his heirs and assigns forever; On his paying to my
lawful heirs the Sum of One thousand eight hundred dollars
to be equally divided amongst them. And the sum of three
hundred and Sixty dollars to be paid by the said Richard
to my brother John Waddel twelve Months after My decease,
which said Sum is the Equal Share of the said John of the
~~sum of the said~~ and the balance due to be paid at the de-
cease of the said Elizabeth Waddel--

And to my said Wife Elizabeth Waddle I Give and Bequeath
All the Horses Hogs, Cattle, & Stock Which now are or may
be mine, for and during the Natural life of the said
Elizabeth, and at her death to my Said stepson Richard
Barnett his heirs and Assigns forever

I further Give and Bequeath unto my said Wife Elizabeth dur-
ing her natural life all my Household and Kitchen furniture,
and all implements of Husbandry and then to my said stepson
Richard Barnett his heirs and Assigns forever

I Give and Bequeath unto my said Wife Elizabeth three negro
Slaves to wit Aggy, Silva, and Peter during the natural life
of the said Elizabeth and at her death they and their issue to
my said Step Son Richard Barnett his heirs and Assigns for-

ever and to Joel Barnett his heirs and assigns forever--to
the said Richard and Joel as Joint Tenants of said negroes--

I Give and Bequeath to my Step-daughter Elizabeth West a Negro
Girl Slave named Tildah, to her, her heirs and Assigns forever

I Give and Bequeath unto Richard Barnett his heirs and assigns forever two negro boy Slaves called Frank and Jim.

I Give and Bequeath unto my Stepson Joel Barnett his heirs and assigns forever two negro boy Slaves called Antony and Isaac

All my Just debts shall be paid from the Notes and Books Accounts due me I do hereby Nominate and Appoint Solomon Hill and Richard Barnett Executors to this my last Will and Testament

In Witness Whereof I have hereunto set my hand and Seal, and published and Acknowledged this to be my last Will & Testament expressly revoking all other Wills, this sixteenth, day of December in the Year of Our Lord One Thousand eight hundred and Nineteen and in the forty fourth Year of American Independence
