this to be my last will and testament that is to say  
principally & first of all I give my soul to god who gave  
it & my body to the Earth to Buried in a Christian manner  
at the Expence of my Executors 2dly as touching such world-  
ly Estate as god has blessed me with I Bequeath the same  
in the following manner & form

Viz I will that all my just debts be paid out of my estate  
3dly I give & bequeath to my wife Mary the Sole & free use &  
possession of my Dwelling house & the land on which I now  
live to be disposed of at her discretion with all my utensils  
of husbandry Stock of cattle hogs & sheep also the three mares  
that Now belongs to me also one Negro boy named Jacob & one  
Negro girl, Named Fve also two tracts of Land latly purchased  
of my son Henry Hambright the two con two hundred & fifteen  
acres 3dly I bequeath to my Daughter Elizabeth Jenkins the  
Sum of two dollars & fifty & cents 4ly I Bequeath to my son  
Jno hambright the Sum of two dollars & fifty cents 5ly I be-  
queath to my son Fred'k hambright the Sum of \$250 6ly I be-  
queath to my son Benj. hambright the sum of two dollars fifty  
cents 7th I bequeath to my son James hambright the sum of two  
dollars & fifty cents 8th I bequeath to my daughter Sarah Aker  
the sum of two dollars & fifty cents 9th I bequeath to my son  
henry hanbright the sum of \$250 10th I bequeath to my daughter  
Mary Price \$250 11th I bequeath to my daughter Sophia Quinn  
the sum of two dollars & fifty cents 12n I give to my son  
David hambright the sum of two dollars & fifty cents

to my son Josiah Hambright one tract of land called  
Regans Containing one hundred & thirty six acres also  
one tract of land called the Brick hill tract containing  
500 also one horse which he now has in his possession  
saddle and bridle 14th I Bequeath to my daughter Char-  
lotte One Negro boy Named Prince one bed and furnature  
saddle and wearing apparel 15th I bequeath to my daugh-  
ter Susanna one Negro boy Named Adam one bed & furnature  
saddle and wearing apparel 16th I now order that one  
Negro man named Isaac my still & vessels be sold with  
my old wagon & other timber to pay the legatees & Con-  
tingent Expences and I do Constitute Mary my wife and  
William Quinn & Josiah Hambright Executors of this my  
last will and testament and I do hereby revoke all for-  
mer wills & Legacies & devices and do Ratify this my last will  
& Testament in witness whereof I have hereunto set my hand  
and seal this 30th day of January in the year of our Lord  
one Thousand Eight hundred & seventeen
