It 3 I give and bequath to my grand daughter Reachel Jamieson one horse for to be worth forty Dollars and ten dollars in Cash when She arives to Sixteen years of age to be paid by my Executor if She should not live to be Sixteen years old my will is that my Sone John Roberts and Andrew Roberts is to have the horse and the money-----

It 4 I gave and bequath to my grande daughter Silindy Roberts five Dollars in Cash for to be paid by Executors-----

It 5th I gave and bequath to my two Sones John Roberts and Andre Roberts all my negroe for to be Hqueley Devided between them and the Cant devide them themselves my will is for my preaisors for

to devid them between them my will is for my Sone John for
to have my ungest bedford coalt my will is for my Sone
Andrew to have all the rest of my horses My will is for
my Sone John for to have two young hafers and my will is for
my Sone Andrew for to have all the rest of my Cate. My will
is for my two Sones John and Andrew for to have my Still be-
tween them my will is for my land for to be devidid between
my two Sones John Roberts and Andrew Roberts and if they
Caunt devid it the must Chouse three men for to do it for
them and the are for Stand to the Devision-----

my will is for my Sone John for to have ten head Sheepe and
ten head of geece and my will is for my Sone Andrew for to have
all the rst of my Sheepe and geece and all my hoges and my
household furniture and Citchen furniture and my plantation
twold all my will is that my Crop of Cotton for to be Sold
and all my gust Debts paid and my Sone John for to git one
hundred Dollars and all my Corn and fother My will is for my
Sone Andrew for to have it and all the Cakh that my Cotton
brings over the above mentioned my will is for my Executors
for to git tombe Stones out of my Crope for me and my wife---

testiment and I do uterly disallow revoake and disannull all

and Seail this twenty nint day of October Eaughteen hundred
twenty Eaight
