4 th I give and bequeathe unto my Son John H Robertson one young Gray Mare

5thly I desire that my Sorrel Mare Call'd Match be reserved for the use of the family that may Choose to stay on the land or premises hereafter mention'd

6th I give and bequeathe unto my beloved wife Charrity Robertson the Land whareon I now live together who Shall keep my said Daughters Sally Men ervy and Rachael Dulathy thereon during their single life free of Charge

7th My Son Benjamin Shall have a decent Support on or from the land or premises above mention'd dureing the Natural life of his Mother the said Charrity Robertson And Should my beloved Wife Charrity Robertson think propper to dispose of the Said premises by Sale. which she is Authorised to do if she Chooses to purchase Elsewhere: Nevertheless should she Sell and not purchase. I Bequeathe a Reasonable portion of the Sale money be reserv'd in the hands of the Ordinary or some agent appointed by him. or in the hands of any other Court. haveing Jurisdiction to that affect, where they may choose to settle themselves, for his Support dureing the

natural life of his mother Charity Robertson and after the Death of the said Charrity Robertson Should the said Benjamin be a Survivor. provided the Land is not heretofore Sold. It Shall then be Sold and the one half of the proceeds. be reserv'd for him in like manner heretofore mention'd dureing his natural life and after his death his moiety shall be Inverted back to my Lawful heirs
8th I disire that as soon as convenient after my Decease that all my property heretofore not mentiond be put to Sale. And all the Just Debts or demands against me be paid and when the money arising from the sale shall be Collected it is my desire that my beloved wife

9 And after the Daeath of my beloved wife Charrity Robertson. all that I have hereunto bequesathed unto her shall be Sold and Equally Divided among my above named Children Includeing my son Benjamin

10th I hereby appoint my beloved wife Charrity Robertson with my Son Thomas Robertson Executors of this my last will and Testament Revokeing all others-----

11 And lastly I have at my Own request and in the presents of Each other Caused William Anderson William Hill Senr with Reazin Talbert Senr to witness the due Executions of this last and Solemn act of my life given from under my hand and Seal this the 11th day of

July 1835
