I John Thompson of the district of York and State of South Carolina; being weak in Body, but of Sound mind and disposing memory; do make and publish this my Last Will and Testament, in manner and form following (that isto Say). It is my wish that my Wife, Cynthia, Shall Receive and I give and bequeath unto her, two Negroes, Viz Absolem and Sophie his Wife, two Beds and Furniture, and a Set of Chinea Ware. I also give and bequeath unto my daughter Malinda Ann, Three Negroes Viz, Caty and her two daughters, Rosinda, and hannah, a bed and Furniture and Seventy five dollars in Cash. I also give and bequeath unto my Son Thomas Dabney, two Negroes, Viz. Sam and Walker, a young Bay Horse, and a Bed and Furniture. I also give and bequeath unto my two Grand Daughters, Nancy M. and Cynthia Jane Wright, One Negro to each Viz. to the former London, and to the Latter Jim. I also give and bequeath unto my three youngest Children one Negroe, to Each of them Viz. to Sarah L. I wish to give Benk to John L. I wish to give Primas, and toCynthia E. I wish to give Simon. It is my wish, that the Residue of my property be Sold, and after all my just Debts are payed, the Balance of the Money Shall be divided into Seven Equal parts, and one part given to my Wife Cynthia one part to Malinda Ann, one part to NancyM, and Cynthia Jane Wright, one part to Thomas D. one part to SarahL. one part to John L, and one part to Cynthia E.

It is my wish, that if Either of my Grand Daughters Nancy M or Cynthia Jane Wright Should die without Heirs of their Body, the Survivor Shall Receive her legacy, but if they Should both Die without Heirs of their Body, then their Legacy is to be equal

Divided between, Melinda Ann, and Thomas D; but Should Malinda Ann die without Heirs of her Body, her Legacy Shall be divided into two Equal parts, one to be given to Thomas D. and the other to Nancy M. and Cynthia Jane Wright; but, Should Thomas D. die without Heirs of his Body, his Legacy Shall be divided into two Equal parts, one to be given to Malinda Ann and the other to Nancy M. and Cynthia Jane Wright; but Should Each one of the above named Malinda Ann, Thomas D., and Nancy M. and Cynthia Jane Wright Die, without Heirs of their Body their Legacies Shall be Equally divided amongst my three youngest Children Viz. Sarah L. John L. and Cynthia E.

But Should one or more of the last named Sarah L. John L. and Cynthia E. die, without Heirs of their Body, their Legacies Shall be equally divided among the Survivor, or Survivors; but Should the whole of them die without Heirs of their Body their Legacies Shall be given to their Mother during her Lifetime, and at her Death, to be given, Equally to, Malinda Ann, Thomas D. and Nancy M. and Cynthia Jane Wright or the Survivor, or Survivors, of the above named Malinda Ann, Thomas D. and Nancy M. and Cynthia Jane Wright, or their Heirs.

It is my wish, that the Legacy which I have given my wife Cynthia be used by her during her Lifetime, and at her death to go to her Children or their Heirs, if living, if dead, to Return to my three Eldest Children, or their Heirs, to be Equally divided amongst them.

And Lastly, I do Constitute and appoint my Brother in Law, James M. Harris, my Sole Executor, of this my Last will and Testament, by me heretofore made. In testament whereof, I have hereunto Set my hand, and affixed my Seal this Second day of June in the year of our Lord, One Thousand Eight Hundred and Thirty two Signed, Sealed, published and declared as and for the Last Will and Testament of the above named John Thompson, in the presence

But Should one or more of the Last named Sarah L. John L. and Cynthia E. die, without Heirs of their Body, their Legacies Shall be equally divided among the Survivor, or Survivors; but Should the whole of them die without Heirs of their Body their Legacies Shall be given to their Mother during her Lifetime, and at her Death, to be given, Equally to, Malinda Ann, Thomas D. and Nancy M. and Cynthia Jane Wright or the Survivor, or Survivors, of the above named Malinda Ann, Thomas D. and Nancy M. and Cynthia Jane Wright, or their Heirs.

It is my wish, that the Legacy which I have given my wife Cynthia be used by her during her Lifetime, and at her death to go to her Children or their Heirs, if living, if dead, to return to my three Eldest Children, or their Heirs, to be Equally divided amongst them.

And Lastly, I do Constitute and appoint my Brother in Law, James M. Harris, my Sole Executor, of this my Last will and Testament, by me heretofore made. In testament whereof, I have hereunto Set my hand, and affixed my Seal this Second day of June in the year of our Lord, One Thousand Eight Hundred and Thirty two Signed, Sealed, published and declared as and for the Last Will and Testament of the above named, John Thompson, in the presence us.
