Know all persons to whom it may concern, That whereas I Margaret Davison of the District of York and State of South Carolina, considering the uncertainty of this mortal life, and being of sound mind and memory (blessed be Almighty God for the same) do make and publish this my last will and testament in manner and form following (that is to say)

First I allow my body to be interred in usual decent manner the expenses thereof to be paid by my executor from the proceeds of my estate.

Also I give and bequeath unto my son Doct James H Davison a certain negro boy belonging to me named Sam.

Also; I give and bequeth unto my daughter Lucinda Patrick a negro girl named Fanny also another negro girl named Mary.

Also; I give and bequeath unto my grand children the children of Sarah C. Latimore a negro woman named Sue and her daughter Judy which property after my death I allow to remain and continue in the possession of my daughter Sarah C. Latimore during her lifetime for her use and benefit and at her death I do hereby particularly empower and enjoin on my executor to have divided equally among her children living at that time.

Also; I give and bequeath unto my grand child Elias Davison the son of Franklin E. Davison decd. a negro child named Edmond and a blacked filley called Bet.

Also, I give and bequeath or devise unto my grandchildren the children of Franklin E. Davison decd the one half of all my right title and interest to the plantation or tract of land whereon I now live, belonging to the heirs at law of Elias Davison decd.

or title to the plantation or tract of land whereon I now live belonging to the heirs at law of Elias Davison dead.

Also, I will and bequeath my household and Kitchen furniture to my children Lucinda Patrick and Sarah C. Latimore to be equally divided between them and their heirs.

Also, I will and bequeath unto my son Elias Davison a balled Horse called Ben.

Also, I will and bequeath unto my daughter in law the widow of Franklin F. Daviann one fallen leaf table.

Also, I will and direct my executor to expose to public vendue my negro boy named Alick the proceeds of the sale of whom to be applied to the payments of my debts, the balance in any, to be equally divided between my son Robert Latimore and my son in law William Scott;

I also, I will and direct that all the rest and residue of my estate of whatever description be exposed to public vendue, the proceeds of which after defraying all necessary expences to be equally divided by my executors among my grand Children, namely the Children of Lucinda Patrick, Sarah C. Latimore and Frankling F. Davison dead.

Lastly I do nominate constitute and appoint James Moore Jr. of the District of York and State of South Carolina my true and lawful executor of this my last will and testament, hereby revoking all former wills by me made.
