 is inevitable I do therefore make & ordain this my Last Will
 and Testament My Beloved Husband the Rev. James Wallis have-
 ing by a Deed of Trust Made to David Hutcheson dated May the
 Ninth Eighteen Hundred & Eighteen Authorised me to Dispose of
 the property therein Contained Agreeable to my own Will &
 pleasure. I do therefore dispose as follows & first of all
 I Recomend my Soul into the hands of Almighty God who gave
 it & my Body to the Earth to be Buried in a Decent manner
 as my Beloved Husband if then Living may Direct & as to what
 worldly Estate it has pleased God to Bless me with I Give
 & Bequeath in the following Manner (Vz) I Give & it is my earnest
 desire that my Beloved Husband James Wallis Would except of
 Two Hundred Dollars to be paid to him as soon after my decease
 as it can be Collected as a small acknowledgement for the
 great care & Attention he has paid me since our Marriage--
 Item--My Brother Samuel Elliot being in a possession of a
 Cotton Gin which I paid for I allow him to keep s'd Gin
 by paying to my Son William E. White when he comes to full
 age the same price it cost me without intrest Also the Hire
 of a Negroe Man caled Dick which he had in the Year 1818.
 I allow him to keep or to draw as much Money out of my Estate
 as will pay s'd hire Item--I Give & Bequeath to my Sister
 Dorcas One Good Bed with curtens & full furniture also all
 my wearing apparel that I may have at my Death--item--it is

my Will that my Negroe Man Ben named in the Deed of Trust
before mentioned be sold--Likewise what ever Stock of Horses,
Cattle, or Stock of any other kind together with the furniture
Belonging to the House, Shop, Kitchen & plantation I allow
to be Sold or Kept as my Executors may think most for the
Benefit of my Estate And this last mentioned property or
the profits arising from it if any of it should be sold
Together with all my Estate & which is particularly speci-
fied in the Deed of Trust formerly mentioned and whatsoever
other property I may be possessed of Either Real or personal
together with what Debts may be due to me after my own Debts
& expences and the above Specified Legacies are fully Paid
I do Give & Bequeath to my Son William F. White his Heirs &c
to be given up to him when he comes to full age--and it is fur-
ther my Express Will & desire that my Executors should use the
Best of their endeavours as their Wisdoms may direct or cir-
cumstances admit to give my S'd Son a Liberal Education & pay
for the same out of the aforementioned Estate Bequeathed to him--
And I do hereby constitute & Appoint My Brother Samuel Elliot
& David Hutchison Executors of this my last Will & Testament &
do hereby Revoke Renounce & Disannul all former Wills or Executors
by me heretofore made or named Testifying this & no other to be
my last Will & Testament
