Calling to mind that it is appointed for man to die; and not knowing how soon my Change may come; do ordain this my last Will & Testament first resigning my soul to him who first gave it to me, hoping for mercy and to be received into the number of the blessed above through the merits and Intercession of Jesus Christ the Righteous Redeemer of man. And as for my mortal body I desire it may be Committed to the Earth and buried in a Christian land decent like Manner; at the discretion of my Executors hereinafter named- And as for my worldly estate the blessed Lord has been pleased to bestow upon me;- I give and desire in manner & form following (Viz) First That all my just debts be honorably paid, and my funeral expenses discharged.- I lend unto my beloved son Henry G. Harris three of my negroes viz Chaney, Mary, Ditcy with their present and future increases duering his natural life; I will that my sd Son Henry G. Harris at any time before or at his death allotte the aforesaid Negroes and their Increases to his children as he may think proper,-I lend also to my beloved son John Harris three of my negroes, named Isham, Allison & Sarah with their present and future increase duering his natural life; I will that my sd Son John Harris at any time before or at his death alotte the aforesaid negroes and their increase to his Children as he

may think proper----

I likewise lend to my beloved daughter Priscilla Ward Seven of my negroes named as follows, Sarah, (the elder) Mariah, Adeline, Caroline, Harriot Sam and Eliza with their present and future increase during her natural life; I will that my sd daughter Priscilla Ward at any time before, or at her death allotte the aforesaid negroes and their increase to her Children as she may think proper.- I also lend to my beloved daughter Polly Saville, Two of my negroes by name Lilah and Betty, with their present and future increase duering her natural life; I will that my sd daughter Polly Saville at any time before or at her death allotte the aforesaid negroes and their increase to her Children as she may think proper And lastly I do give and bequeath unto my beloved Son Nathaniel Harris the Sum of ten shillings Sterling or two dollars and thirteen cents and three fourths, to be raised or levied out of my estate by my Executors---

I do hereby nominate and appoint my son Henry G Harris to be my whole and sole Executor of this my last will & Testament,--

Disanulling all former will or wills made by me, and constituting this to be my last.-
