In the name of God Amain this 8th day of January 1822

I Marey Leathem of York Destrict State of South Carolina Being
varey Sick and low in bodey but of perfict mind and memorey
theanks be to god therefor Calling to mind the mortaity of
my bodey and knowing that is is apointed for Weoman once to die
do make and ordain this my last will and testament that is to
say principally and first of all I gave and recommend my Soul
unto the hands of almighty God that gave it and my body I
recommend to the Earth to be buried in a deacint Cristian
manor at the Discretion of my Executors nothing deuting but at
the genorel resurrection I Shall receive the Saime again by the
mighty power of god and as turning Such Wourldly Estate Where-
with it hath pleased God to bless me within this life I gave and
Dispose of the following manner and form-----

Item I gave and bequeth to my Dautor Reachel Simons my Deeling
hous and all the oald Clear Land and the wood land that lies
between my Cler land and his line from the upor Corner next to
Robert Leathems down to the lower Corner of the oald field west
the Cotton field Excepted five Eacors South East Cornor lies
my Cauben (?) and furniture one bead and furniture and all my
Household furniture-----

Item I gave and bequeath to my Sone Andrew Leathem the one
half of all the rest of my wood land goining him and the Strip
lying along the west sand to simons and John Wilsons line and
the one half of the meadow and my pot and forty six Dollers
that I have in hand-----

Item I gave and bequath to my Sone Robert Leathem all the other
half of my wood land goining to himself on the East Sand with

the Cotton fieald the South East Corner of my Clear land
and the other half of my medow and the balene of my Cask
in hand one bead and furniture and my Cow and my Brass

Siftor-----

Item I gave and bequath to my dautor Saly french five Dollers

Item I gave bequath to my dautor agness Wilson five Dollars fo
to be paid by my dautor Reachael and andrew and Robert-----

I also alew my Neagro girl Luce for to mak her Choice of my
Childring for to live with that is here and if the move away
the She is to take the nixt Cheice for She is not to be moved
from here while there is one of them here-----

Item I do likwis Constitute make ordain my Sone Andrew Leathem
and my Sone Robert Leathem my Sol Executors of this my last
will and testament and I do utterly Disallow revoake and dis-
anul all and every other form testaments wills leagacies and
beaquaths Cartifying--and Conforming this and no other to be
my last will and testament In witness whereof I have hereunto
Set my hand and Seal this the 8th day of Janury 1822
