I Nathan Moore of York District State of So. Carolina being of sound mind and memory, calling to mind the uncertainty of life, and being desirous of dividing amongst my several children such worldly estate as it has pleased God to bless me with; do make & ordain this my last will and Testament in the manner following Viz-----I give and bequeath to my son Thomas one hundred acres of land; it being the land on which he now resides and for which I have made him a title I also give the sd Thomas a negro he has now in possession to him & his heirs forever I give and bequeath to my son Zenas one hundred acres of land adjoining a tract formerly owned by John Harkness for which I have executed a deed dated 7th Feby one thousand eight hundred and twenty eight. I also give to sd son Zenas a negro boy named Lewis to him & his heirs forever I give and bequeath to my son Robert one hundred acres of land beginning on a stake Zenas Moore's corner thence S. 67W 27.50 to a post oak thence N. 23 W. 36.50 to a stake thence 67 E 28 to a forked water oak Thence S. 23 E 36.50 to the beginning I also give to sd Robt a negro girl named Isabella youngest child of Bettys to him & his heirs forever----- I give and bequeath to my son Eli one hundred acres of land more or less bounded on the East by Robt Moore's on the N by Williamson's & Walker's on the S. by my own lands according to a survey lately made by Hanna and laid out unto sd Eli to him & his heirs forever I give and bequeath to my three sons Jesse John and Stanhope the remainder of all my lands to be equally divided between them according to quantity and quality to them and their heirs forever I also give to my son Jesse a negro man named Bob-- I also give to my son John a negro boy named Bill I also give to my son Stanhope a negro boy named Leroy to them & their heirs forever.

sd daughter be paid annually twenty dollars out of the proceeds  
of the property given to Jesse John & Standhope until Standhope  
attains the age of twenty when my said daughter Eliza is to take  
possession of the sd negro woman Ritty-----

I give and bequeath to my daughter Peggy a negro girl named Minn  
I also give to sd daughter Peggy two hundred dollars to be paid  
her when she gets possession of the above named Minn to her and  
her heirs forever I give and bequeath to my daughter Jincy a nego  
girl named Pat to her and her heirs forever---It is my further  
will that my two daughters Peggy & Jincy each to have a horse  
saddle & bridle & house hold furniture equal to my dauthter Eliza  
when she married and that they have their mentainances off the  
land given to Jesse John & Standhope untill they manry--- I give  
and bequeath to my grand child Daniel son Of Eli's a negro girl  
named Rosetta to him & his heirs forever--- I also give and be-  
queath to my three sons Jesse John & Standhope all the remainder  
of my estate both negroes & all other personal property whatsoeve  
but leave it at the discretion of my executors to sell any part  
of the same to discharge my Just debts---It is my further will & d  
ire that all my negroes and all other personal property to remain  
undivided until my youngest child is twenty years of age but shou  
any of my children manry before that time they are then to have  
the property herein given them---- It is my further will and de-  
sire That my son Standhope be sent to school until he acquires a  
good education & that my executors have the management of his par  
of my estate for that purpose-----

Lastly-I do constitute and appoint my friends Sam'l Rainey, Allie  
Hope and my son Zenas Executors of this my last will & testament  
revoking all others- In testimony whereof I have hereunto set my  
hand and affixed my seal this 3d October 1829
