South Carolina) I Phillip Sandefur of the State and Big-
York District) triet aforesaid do make and ordain the
following as my last Will and Testament Viz---to my beloved
wife Elizabeth Sandefur I leave and bequeath my Negroes Pat.
Tom Tony Moses. Jack. Sarah and her Child Harriet to her
proper use for ever Also all the stock of Horses I own Al-
so all my stock of cattle sheep and Hogs and all my Farming
and plantation Tools and Household and Kitchen furniture to
her proper use forever Also all the stock of Money I have
either in Bank paper or Specie as also all legal Debts which
may be due to me by Bond Note or otherwise to her forever Al-
so all the Crop now or which may be on the land at the time
of my Decease and my riding Chair and harness--

I also give and bequath to my beloved Wife Elizabeth the
plantation I now live and at her death I dispose of it as is
hereafter directed--

To my Daughter Mary Lacey I bequeath Ten Dollars To my son
William Sandefur I leave and bequath my Negro Man Ben and four
Hundred Dollars to be made out of the property hereafter
mentioned and to be paid in eighteen months after my Decease
The above named Negro man Ben I order to be applied to the
use of my Son William for the advantage of his family and give
him no power to dispose of him and order he shall not be applied
to the payment of any of his debts or contracts--

To my Daughter Elizabeth Sandefur I leave and bequeath my
Negroes Tab. Nance, and Jane

To my son Green Sandefur I leave and bequeath my Negroes Nel-
son and Nick

To my Son Lowry Sandefur I leave and bequeath five hundred Dollars to be paid in eighteen months after my Decease--
To my son Philip I leave and bequeath my Negroes Brook, and Ralph and my plantation I now live on at the Death of my Beloved Wife Elizabeth

To my Daughter Cathrine Gordon I leave and bequeath my Negroes Alice and Winny

To my Daughter Caroline Sandfur I leave and bequeath my Negroes Christy and her Children Nat and Violet and girl Sillar--

My Negroes Peter and Belinda I order to be sold to pay the Legacies above or before mentioned and debts and funeral expenses and any overplus I give to my beloved Wife--

It is meant and understood that out of the above property and money left to my beloved Wife she shall immediately after my Disease put five hundred dollars to interest for my grandchild Calvin Philip Sandefur (son of Green) which principal of five hundred Dollars with legal interest he is to receive from her or her executors or Administrators at her Disease or as soon as he shall come of age or that the above be applied to his education

Signed Sealed and acknowledged as the last Will and testament of Philip Sandefur Sen'r. June 16th 1817

I appoint Henry Carter and Beloved Wife Elizabeth Executors of this my last Will
