(December the 18, 1816)

In the Name of God Amen the Eightinh of April in the year of our Lord 1816 I Robert Howie of the stat of South Carolina York District Being in a very good state of helth and perfit in mind and memoroy thanks, thanks Be Geven unto God for the sam and calling to mind the mortality of my Body knowing that it is appointed for All men once to Die Do and ordain this my Last will and testament that is to say principally and first of All I give and Recommend My Soul into the hands of God that give it and for my Body I Recomment it to the Earth to Be Buried in a Cristian Lick and Decent manner at the Discretion of my Executers Nothing Doubting But at the general Resurrection I Shall Recav the Same again By the Mighty power of God and tuching such worldly Estate Wherewith it hath pleased God Bless me in this life I give Devise and Dispose of the same in manner and form following that is to say

in the first I give and bequeath ti my Eldeste Doughter Margrat Howie a Negrow woman Named Pat and horas and sadel Also I give to my Son William Howie a tracks of Lands that I Bought from Samuel Carson and Androw Carson which I now Ocopie Contenning 140 akers mor or Less Also I give to my Daughter Mary McConnel to the Amount of fifty Dolars to Be pad in hoars or Cattel as may Be most convenint to my Executers Also I give to My Daughter Sarah Howie a Negrow geril Nemed hanna and horase and Sadle Also to my Son Alexander Howie the track of Land I now Live upon with the tract forning it formerly kown by Name of Rottene place Also a negrow Boy Named Dave and Also feeb and pady.

As for my Cattel and houshold furniteur such as Books Beds and

Turner and All other things I Allow them to Devid Among them-  
selves that is in three Shears as that it Suits Margrat and  
Sarah and Alexander And I Likewise Constitute make and ordain  
my only and sole Executors William Howie and Alexander Howie  
of this my Last will and testament and I Dow herboy utterly  
Disallow Revoke and Disannull all and Every other former test-  
aments wills and legacies Requestes Executers By men in any  
ways Before this time Named willed and Bequeathed Ratifying  
and Confirming this and no other to Be my Last Will and testa-  
ment in witness where of I have hereunto Set my hand and seal  
the Day and year above written
