Death.

Viz. David Byers McCarter; Simpson Hervey McCarter and Eli Erwin
McCarter; I give and Bequeath The Plantation or Tract of Land
whereon I now live; Also One Negro Boy named Dick Perkins; Also
One Negro Boy Child named Andrew Jackson; Also One Negro Woman
named Temay and her Child Emeline with all her future offspring;
Also One Negro Woman named Amey and her Two Children Flora and
Hanna Meihela; Also Three Head of Horse Beasts Viz. One Gray
Mare and One Sorrel Mare with her Yearling Colt; Also all my
Stock of Cattle & Hogs and farming Utensils; One Wagon and Gear;
Also One Clock, One Corner Cupboard and half its furniture; Al-
so all my Household & Kitchen furniture to them the aforementioned
Three Children of my Son Minor McCarter thier Heirs and assigns
forever

3rd To my Grand-Daughter Margret Mermon I give and Bequeath One
Feather Bed and furniture, And Also the half of my Cupboard
furniture.

7th To my Daughter Margret Dickson Cobb (wife of Clinsby Cobb)
I give and Bequeath Two Dollars in Cash.-----

8th To my Son Thomas McCarter I give and Bequeath Two Dollars
in Cash.-----

9th To my son Minor McCarter I give and Bequeath Two Dollars
in Cash. ----And I do Nominate and Appoint my Son in law Clinsby
Cobb and my Son Minor McCarter Executors of this my last Will
and Testament, Declaring and pronouncing this and this only to
be my last Will and Testament,--In testimony whereof I have here-
unto set my Hand and affixed my Seal this Sixth Day of December
in the year of our Lord one Thousand Eight Hundred and thirty six
