

In the name of God Amen I Susanna Dunlap of the State of South Carolina York District Calling to mind the uncertainty of this mortal life and being of perfect mind and memory Blessed be God for the Same Do make and publish this my last Will and testament First I will and desire that all my Just debts may be paid by my Executors. Also I will and Bequeath to my Son James P Dunlap and to his heirs for Ever. two tracks of land being in the District aforesaid viz one tract of one hundred acres whereon I now live which was Conveyed by James Patton to William Dunlap also one other tract of one hundred and Sixty acres of land which was Conveyed By the Said James Patton to the Said William Dunlap Reference being had to the above mentioned grant and Conveyance a Discreption of the Said lands will more fully appear. I also will and bequeath to my Son William B Dunlap and to his heirs for Ever one negro man named Charles one negro woman named Jemima and hir Son Isaac one negro woman Rebecca and one negro woman Susan and two Children I also will and bequeath to my grand Daughter Susanna Dunlap the one half of the value of a negro girl named Agga and I also will and bequeath the other half of the value of the value of the above named agga to my two grand Daughters Lurilla Susanna Jane and Margaret Catherine ann I also will and bequeath to my Daughter Elisabeth Hagins and to her heirs for Ever. one negro man named Jeff one negro woman named patience and three Children one negro boy named Sam. And I further will and bequeath to my Said Son James P Dunlap and to his heirs for Ever one negro man named Abram one negro Woman named Clee one negro boy named Candy and one negro boy named Charles. I also will and bequeath to my Grand Daughter Mary P Dunlap and to my Grand Daughter Susanna Dunlap to Each of them three hundred Dollars in money. Provided Robert White gives Each of them a negro or should he give his grand Daughter Susanna Fergessen a negro and his grand Daughter Mary P Dunlap none. then I do bequeath the Six hundred Dollars

to Mary P Dunlap Exclusevely at my Decease I do allow that Six hundred Dollars be raised to pay to my two grand Daughter Susanna Fergessen and Mary P Dunlap and that my Son William B Dunlap Do pay two hundred and fifty Dollars and my daughter Elizabeth Hagins Do pay two hundred and fifty Dollars and that my Son James P Dunlap pay the Sum of one hundred Dollars And I do hereby nominate ~~Constitute~~ and appoint my Son William B Dunlap and my Son James P Dunlap my Sole Executors of this my last will & testament hereby revokeing & makeing void all & Every will or wills at any time heretofore by me made and do declare this to be my last will and testament. In Witness whereof I the Said Susanna Dunlap have hereunto Set my hand and Seal this 21st Day of october in year of our lord 1839
