2nd I lend to my Daughter Sarah Elms one negro Woman and her Child Rachal, that is now in her possesion and their Increase. for the express purpose of nursing raising and Supporting her Children during her life, and after her my Said Daughters death. I give and bequeath Said two negroes Mariah and Rachal and their Increase to her Children to be equally divided among all the Children She may then have living, also all her beds and furniture and other things that I have let her have I leave far the Same purpose

Girl named Sinder and her increase from this time one bureau, one table together with all the beds and furniture, and all other Household furniture that She Claims as hers, and that my wife knows to be here---

4 I give and bequeath to my Daughter Elizabeth G Meacham the Negro Girl Eliza that is now in her possession and all the beds

it give to my Son Thomas Barnett one bed and furniture

tation Whereon I now live during her life of wroowhood bth F

give devise and bequeath unto my son George G Bannett the plan
tation Whereon I now live after my beloved Wifes Beath or Mar
riage provided he will pay my Son Thomas Barnett four Hundred

Dollars in twelve months after my wifes Death or Marriage, but

it is understood that unless my Son George G Barnett pays to my

Son Thomas Barnett the above Sum of four Hundred Dollars Within

the time above Stated I will the land to be Sold and the money

arising from such sale to be Equally divided between my Sons

George and Thomas-

9th I give and bequeath to my beloved wife Ann Barnett all the rest of my negroes that is not above will'd Which is now in my possesion. Sixteen in number With their Increase from this time together with all the rest residue and remainder of my property of what Kind and nature Soever her paying all my Just debts out of what I have Will'd her-

10th and lastly I nominate and appoint my friend BenJ. Person and my Son George G Barnett Executors both of the District and State above Written to this my last will and testament hereby revoking all former Wills by me made in Witness Whereof I have hereunto Set my hand and affixed my Seal this 14th day of January 1828.
