 Also to my son Richard I give the plantation which now lives and
 also conferm to him the property he has before rec'd from me and
 I also allow my son Richard to get one hundred dollars in Money
 to my son John I give the land & other property he has heretofore
 received from me to my Son Littleton I give one Thousand dollars
 includeing what he has already received from me To my son Jesse
 I conferm I conferm the Land already conveyed to him Also to my
 son Jesse I give one hundred dollars to my son William I confirm
 the tract of land already conveyed to him by me to Thomas I give
 un my son I confirm the Land conveyed by me to him To Jephtha my
 son I confirm the Land already conveyed to him To Chesley my son
 I confirm the Land already conveyed to him Also to Chesley I give
 my negroe boy Abram at his mothers death To my daughter Mary price
 I give my negroe woman Mary & her child Caroline Said Negroes to
 go to her & the heirs of her body To my daughter Milley I give
 twelve hundred dollars the above twelve hundred already paid To
 my Daughter Sarah I give my negroe Girl Emaline & at the death

of her Mother I give her my negroe Boy Anthony said negroes to go at the death my daughter Sarah to the lawfull heirs of her body if any & if no such heirs Said negroes to return to my estate & to be devided among children To my Daughter Elizabeth I give my two negroes Andrew & amanda also at the death of my wife I give to my daughter Elizabeth my negroe Girl patsey Said negroes at the death of my daughter Elizabeth to go to the heirs of her body if any & if there is none such then to return to my estate & be equeally divided among my Children To my daughter Nancy I give my negroe boy Joe also at the death of my wife I give my negroe girl Rose to my said daughter Nancy dureing her life & then to the heirs of her body if any & if there none such then to return to my estate & be equeally divided among all my children. Lastly I do hereby appoint my Wife Elizabeth to be my Executrix & my son Richard to be Executor of this my last will & do hereby revoke all other wills by me heretofore made In testamony whereof I have hereunto set my hand & seal this second day of october in the Year of our Lord One thousand
