I William-Henry Senior of the State of South Carolina and District of York, being aged and Infirm, but of Sound and perfect mind and memory, and knowing that it is appointed for all men once to die, do make, ordain and publish this my last will and testament, and do thereby dispose of all my worldly estate as follows

First I order that all my just debts be paid

Secondly-I give and bequeath unto my Son James Henry, my negro man Slave named Aaron, my Mulatto woman Slave named Rose, and my negro boy Slave named Charles, to him and his heirs forever

Item I give and bequeath unto my grandson Francis Henry Son of my Son James Henry, my negro boy Slave named Prunus or Prime, and my Saddle, to him and his heirs forever

Item I give and bequeath to my grandson William Henry, Son of my Son James Henry, my negro boy Slave named Isaac to him and his heirs forever

Item I give and bequeath unto my grand daughter Elizabeth McKean Henry, daughter of my Son James Henry, my negro boy Slaven named Toney, my bed and furniture, two pots, a spinning wheel, a chest and a large pewter dish, a large pewter bason, and four pewter plates, to her and her heirs forever

Item I give and bequeath to my Son Francis Henry one large pewter dish, one large pewter bason, and four pewter plates to him and his heirs forever

Item Through respect and regard for my old negro woman Slave named Sarah, I give and bequeath her to such one of my children, as she shall within ten days after my decease signify to my Executors, to be her choice of them, if such one of my children

shall accept of her, but if not, then to such one of the rest of

~~she shall make choice of in ten days~~ and

shall accept of her to such child and his or her heirs forever

Item It is my will and desire that my negro boy Slave named

Syrus, be Sold by my Executors to the best advantage and that they apply the monies arising from Such Sale, to the payment of Such of my son James Henry's debts, as I am Security for

Item I give and bequeath to my Son James Henry, four head of cattle, a Reel, a table, a Looking Glass, all my farming Utensils, the remainder of all my house hold and kitchen furniture, all the rest and residue of my estate not herein before, particularly devised and bequeathed, to him and his heirs forever

Item I do hereby confirm to each and every of my children all the real and personal estates which I have heretofore given into the possession of them, of each and every of them to them and their heirs forever

Item I do hereby nominate and appoint my Son James Henry, and my trusty friend William McGill, my executors to Execute and carry into effect this my last will and testament-

In Witness Whereof I have hereunto Set my hand and affixed my Seal, and do hereby publish this my last will and testament, hereby revoking and nullifying all and every former will or wills by me heretofore made or executed, this 8 day of April 1816 in the year of our Lord one thousand eight hundred and fifteen, and in the fortieth year of the Sovereignty and independance of the United States of America
