I William Litle of the District and State afore-
said do make and ordain this my last Will and Testament in the words
& form as follows Viz.

Item-1st To my wife Elizabeth Litle I give and bequeath one Negroe
Man named Dave, one negroe Boy named Sam, & one Negroe Woman named
Winney during her life time or widowhood; also one sorrel mare
Roset a & her offspring to dispose of as she pleases.--I also leave
& Bequeath to said Elizabeth Litle during her lifetime or Widow-
hood untill my Son Wiley Litle becomes of Age, for the maintainance
& support of the Children all that Plantation or Tract of Land where
on I now live, at which time it is to be equally divided between my
two sons Wm. Litle & Wiley L. Litle, But it is understood that my
wife E. Litle is to have during her lifetime or Widowhood a part
of the Plantation or Competency thereof for herself & her hands to
Cultivate with the House & all the out Buildings, Household & kit-
chen Furniture (except one Bed to each female Child when they become
of age or Marry) Also the farming Utensils and farm Horses & such
a part of the Stock as may be necessary for Carrying on the farm
or support of the Family-----

Item-2nd To my Daughter Sarah Sadler I give and Bequeath one negroe
girl Named Ruth one Negoe Girl named Matilda, one Bay Mare Paulina
& one sorrel Colt one year old, two Beds & Furniture with all the
other articles she has received of me when Married

Item-3rd. To My daughter Elizabeth Litle I give and Bequeath One
Negroe Girl Named Ann, one Negroe Girl named Vilet one Bay Horse
Nocher and one Bed and Furniture

Item 4th To My Daughter Polly Litle I give and Bequeath one Negroe
Girl named Lavina, one negroe Child named Harriett, Also one sor-
rel mare named Mariah and one Bed & Furniture,

Item-5th. To my Daughter Jane Little I give & Bequeath one negroe Girl named Bliza one negroe Girl named Sophia, Also 1 Bed and Furniture and one horse Saddle & Bridle of a Good quality to be procured by my Executors. out of the profits of the Plantation when she becomes a proper age to require it.

Item-6th. To my Daughter Margaret Little I give and Bequeath one negroe Girl named Mariah, one negroe Woman named Phebe one Bed & Furniture & one Good Horse Saddle and bridle to be procured by my Executors out of the profits arising from the plantation, when she becomes a proper age to require it.

Item-7th To my son William Little I give and Bequeath One Negroe Boy named Absalom Also one half of the Land whereon I now live and the West side of S'd land when divided.

Item-8th. To my son Wiley L. Little I give and Bequeath one negroe boy named Tom, Also one half of the land whereon I now live and the East side of S'd land when equally divided.

It is also my will & desire that the Young Horse Panloon remain in the Family & be disposed of as my Executors (herein after named) sees proper, and the proceeds arising from the said horse be appropriated to Educating and Cloathing the Children.

It is also my desire that the whole of the property above named be kept together on the plantation until the Legatees Marrys & be conducted under the direction of my Executors--And the proceeds arising from said Farm after Educatin maintaining and Cloathing the Children to be equeally Divided among all my female Children.

It is also my desire that all the property Bequeathed to my wife Elisabeth Little at a Legal time after her decease or Marriage be appraised or cause to be appraised by my Executors, and one two, three or four of the Legatees or as Many as may see proper take said property at the appaisement and pay the amount of S'd appraisement which sum is to be equally Divided among each and every one of the Female Legatees.

It is also my desire that if one or more of the Legatees dies without an Heir, that their property be appraised as above directed and

one or more of the Legatees take it at the appraisement & the amount to be equally divided among the Surviving Legatees. Viz. the Female
It is also my express Will & desire for the small Tract of Land lying on the North side of Troads Fork adjoining Thomas Roachs Land with StarJanus and all the other property not mentioned in my will & whatever can be conveniently spared to be sold at Publick Auction, and the Money appropriated to the payment of all my Just Debts and the remainder if any to be equally divided among each Female Legatee except one hundred Dollars to be put on interest which I give & Bequeath to my Daughter Sarahs Oldest Child when he arrives at the age of twenty one years.

It is also understood that none of my Books nor wearing apparel shall be put to sale But shall be divided among the Legatees as my wife E. Little sees proper. I do appoint constitute & ordain Elisabeth Little my wife Executrix and the Ordinary of York District & herself to appoint another Executor of this my last will and Testament.
