

STATE OF SOUTH CAROLINA

I William Moore, Snr. of York District State of South Carolina being of sound mind and memory and knowing that it is appointed for all men once to die, do constitute and establish this my last will and testament in the manner and form following viz
Item I will and bequeath to my son James G Moore the plantation whereon he now resides adjoining Alexander Barnett and others also one hundred dollars to be paid him by my executors out of the sales of my property after the decease of my wife Mary Moore.
Item I will and bequeath to my son Walter W Moore the plantation whereon he resides in Lincoln County North Carolina on the waters of Crowders Creek adjoining James Craig and others containing one hundred and seventy four acres--also one hundred dollars to be paid him by my executors out of the sales of my property which is to take place after the demise of my wife Mary Moore-----
Item I will and bequeath to my son William Moore Jnr. the plantation whereon I now reside containing about two hundred and twenty three acres on waters of Beaver Name of Crowders Creek adjoining lands of Edward Moore, Snr and others but this donation is not to take effect till the death of his mother Mary Moore at her death he must become possessed of said lands and not before
Item I will and bequeath to my daughter Nancy Moore Alias Nancy Suggs my two negro girls Milly----- and Candace Milly is now in her possession-----
Item All the remainder of my estate after paying my funeral expences and just debts I will and bequeath to my wife Mary Moore during her natural life to be kept on the plantation where I now reside for her use and support and at her death to be sold and the above donations paid and the balance equally divided among

my children in the following manner, To Walter W Moore or the
heirs of his body one share to James O Moore or the heirs of his
body one share, to William Moore Jnr the heirs of his body one
share to Nancy Moore alias Nancy Suggs or the heirs of her body
one share, Item my will is that my wife Mary Moore shall have
the plantation whereon I now reside on waters of Beaver dam of
Crowders Creek adjoining Edward Moore Shr and others containing
two hundred & twenty three acres for and during her natural
life and then to go to my Son Wm Moore Jnr. as above stated-----
I do hereby nominate and appoint my son James O Moore and my son
in law Thomas E Suggs executors to this my last will and testament
hereby revoking all others----In Testimony of which I have here-
unto set my hand and affixed my seal this thirteenth day of Jan-
uary in the year of our Lord one thousand eight hundred and thir-
ty eight and of the sovereignty and independence of the United
States of America the Sixty second--
